

## iGA launches Labour Force Survey 2026

In line with efforts to strengthen the national data framework and improve labour market indicators, the Information & eGovernment Authority (iGA) announced the launch of the 2026 Labour Force Survey (LFS), which will be conducted from January to December 2026.

Targeting a random sample of more than 8,000 households across the Kingdom's governorates, the study aims to collect comprehensive data on the Kingdom of Bahrain's labour market, including information on occupational structure and the economic activities of the employed population. The data will be compiled according to the standards and recommendations of the International Labour Organisation (ILO), allowing for regional and international comparability.

### Vision

Duaa Sultan Mohamed, iGA's Deputy Chief Executive for Statistics and Population Registry, said that the Labour Force Survey reflects the Government's vision and iGA's commitment to the directives of His Excellency General Shaikh Rashid bin Abdullah Al Khalifa, Minister of Interior and Chairman of the Ministerial Committee for Information and Communications Technology (MCICT).

She also noted that continuing to conduct these studies and surveys supports informed decision-making, policy development, and the formulation of national plans and strategies to further advance the Kingdom's development.

# A higher ceiling

Southern Municipal Council backs BD13,000 cap for home renovation aid

**B**D13,000 could become the new upper limit for renovation support under the Cities and Villages Development Project.

The Southern Municipal Council voted yesterday to write to the Minister of Municipalities Affairs and Agriculture, urging a change to the project's guidance manual.

The council backed, unanimously, a proposal from Mohammed Darraj, the member for the Fourth Constituency, to lift the cap from BD10,000 to BD13,000, or less, but only in exceptional cases.

Darraj told the council: "The expected actual cost of carrying out the works has become higher than the amount estimated

and approved in the first phase. There is a need to complete the project without placing additional burdens on citizens. Citizens rely on limited salaries, which makes them unable to cover any additional costs."

He linked the request to the aim of the Cities and Villages Development Project's renovation and rain insulation service, which targets safe and suitable housing for low-income citizens, with the aim of raising housing standards across the Kingdom.

In its recommendation, the council referred to provisions in the Municipalities Law and its executive regulations that allow municipal councils to propose local projects and follow up services within their remit, while co-ordinating with the relevant authorities.

The proposal also notes that the "houses at risk of collapse" project has been stopped since 2012, leaving some urgent cases relying on renovation support despite the scale of damage in some homes.

## Vehicle embezzlement and impersonation case

**I**n a further connected case, the loss of ID cards inside a vehicle led to the uncovering of a broader fraud and vehicle embezzlement scheme.

The suspect had used an identity belonging to a detainee serving a sentence at a rehabilitation centre to rent a vehicle, which he failed to return.

The rightful owner of the ID later confirmed that he had neither rented the vehicle nor signed the contract, and that his card had been stolen.

### Signatures

Forensic examination established that the suspect had forged the signatures on the rental agreement, and financial investigations confirmed that payments for the vehicle rental were made using a phone num-

ber registered in the suspect's name.

The Public Prosecution charged the defendant in 2025 with using forged official documents, impersonation, fraud, document forgery, misuse of a forged document, vehicle theft and causing financial damage to the rightful owner.

The High Criminal Court set 10 February as the date for issuing its verdict, with the defendant remaining in custody.
