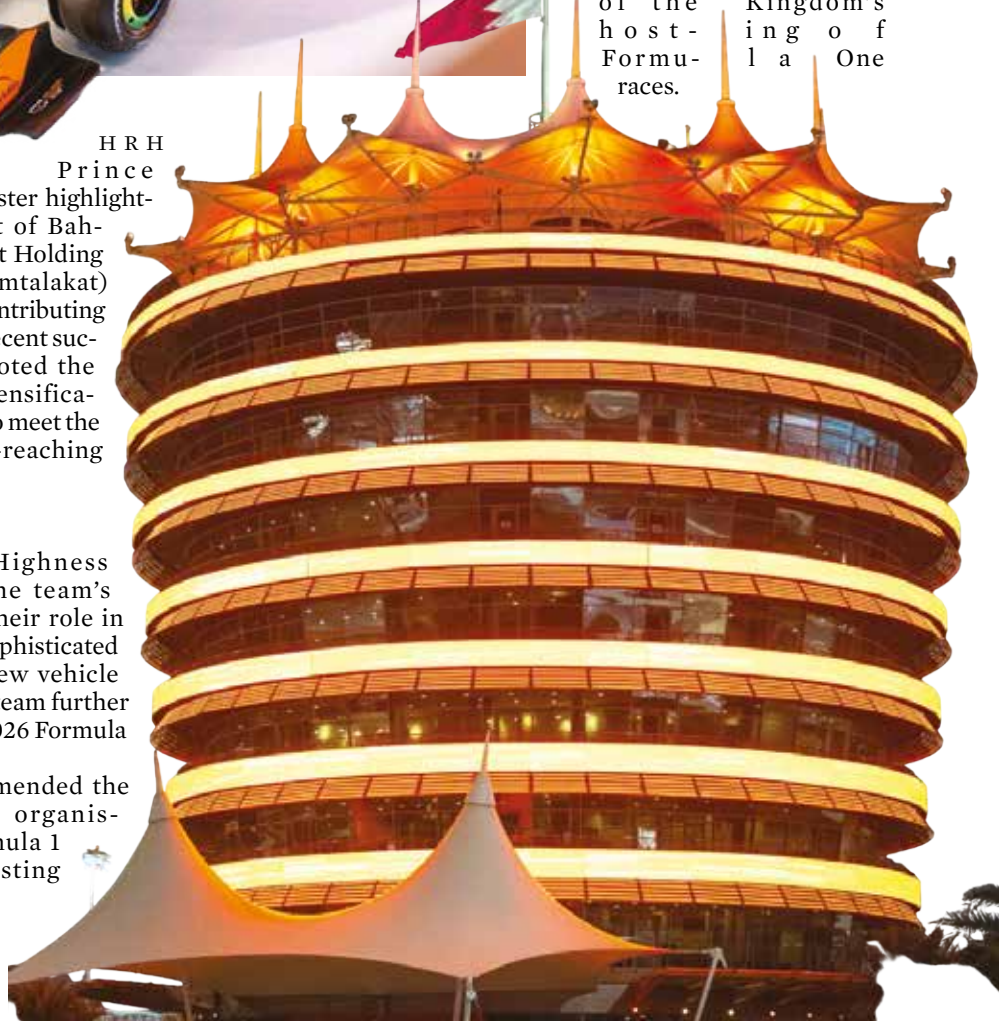

Government resists plan to extend court appeal time from week to month

A draft law before Parliament would give defendants 30 days to object to criminal orders issued by the Minor Court, up from the current seven.

The government is urging MPs to reconsider.

The change would amend Article 277 of the 2002 Criminal Procedure law. Public prosecutors would have 30 days from the date the order is issued.

Other parties would have 30 days from the date they are notified.

If an objection is filed at the court registry, the criminal order is set aside and the case proceeds under the usual procedure, as though the order had not been issued.

In its written memorandum accompanying the bill, the government argues that the criminal order system is meant to be a summary route for minor cases, handled without a hearing unless an objection is submitted within the deadline.

It says seven days is sufficient because an objection does not need reasons or legal argument.

A simple request to contest the order and have the case heard is enough.

Price stability

Cabinet reviews market conditions to ensure availability of essential goods during Ramadan

The Cabinet reviewed the availability of consumer goods in the market and the stability of their prices ahead of the Holy Month of Ramadan.

It commended the efforts of the Ministry of Industry and Commerce, the Bahrain Chamber of Commerce and Industry, and the commercial sector, recognising their role in maintaining price stability and ensuring a steady supply of consumer goods during the holy month.

The Deputy King, His Royal Highness Prince Salman bin Hamad Al Khalifa, yesterday chaired the weekly Cabinet meeting at Gudaibiya Palace.

The Cabinet commended the address delivered by His Majesty King Hamad bin Isa Al Khalifa, the Supreme Commander of the Armed Forces, during His Majesty's visit to the General Command of the Bahrain Defence Force (BDF), on the BDF's 58th anniversary.

It highlighted the importance of the bilateral defence agreement between the Kingdom of Bahrain and the French Republic, which was signed during

the talks held between HM the King and His Excellency Emmanuel Macron, President of France, during His Majesty's official visit to France at the invitation of President Macron.

The Cabinet extended its congratulations to His Majesty the King on the anniversary of the National Action Charter, and congratulated Bahraini citizens on this national occasion.

The Cabinet then commended the outcomes of His Royal Highness's official visit to the State of Kuwait, during which

18 illegal workers detained, 93 other violators deported

● **LMRA carries out 1,596 inspection campaigns and visits**

● **Legal measures taken over violations**

Eighteen violating and irregular workers were detained and 93 others deported following 1,596 inspection campaigns and field visits carried out by the Labour Market Regulatory Authority (LMRA) between February 1 and 7.

The inspection campaigns and visits also resulted in monitoring several violations related to the provisions of a number of regulating laws, especially the LMRA and the Residency Laws in the Kingdom of Bahrain, noting that legal measures were taken regarding the observed violations.

A total of 1,559 inspection visits were carried out on various shops in all governorates, in addition to 37 joint inspection campaigns, 15 campaigns in the Capital Governorate, 8 campaigns in the Muharraq Governorate, 7 campaigns in the Northern Governorate, and 7 campaigns in the Southern Governorate.

The government entities

that participated in the campaigns are the Ministry of Interior, represented by the Nationality, Passports and Residence Affairs (NPRA), the Governorate's respective Police Directorate, and the General Directorate of Crime Detection and Forensic Science, and the General Directorate of Verdict Enforcement and Alternative Sentencing, as well as the Ministry of Industry and Commerce, the Social Insurance Organisation (SIO), and Bahrain Tourism and Exhibition Authority (BTEA).

Coordination

The LMRA affirmed the continuation of joint coordination with government agencies to intensify inspection campaigns in all governorates of the Kingdom, and to address any violations or practices that negatively affect the stability and competitiveness of the labour market or harm the economic and social security of the Kingdom.

It renewed its call on all members of society to support the efforts of government agencies in addressing illegal labour practices, by reporting violations via the electronic form on the authority's website www.lmra.gov.bh or by calling the authority's call centre on 17506055 or via the government's Suggestions and Complaints System (Tawasul).

Royal support

Push for urgent road maintenance

The Northern Municipal Council has called for urgent action to address road maintenance issues in the Ninth District, warning that delays are worsening daily conditions for residents and increasing safety risks.

The issue was raised during the council's Ordinary Session 11, following complaints submitted by council member Abdullah Mubarak Bilal Al Qubaisi.

Members highlighted a rise in reports related to damaged road surfaces, uneven levels and repeated water accumulation in several areas of the district.

Residents, councillors said, have complained that deteriorating road conditions are causing inconvenience to motorists, damaging vehicles and making movement difficult for pedestrians, particularly the elderly and children.

Al Qubaisi stressed that the volume of maintenance requests has increased noticeably, reflecting long standing neglect in some locations.

Revenge killing

Two defendants tell court killing ‘retaliation’ for cousin’s death 12 years ago

Two men accused of murdering a man in his fifties told a court yesterday they stabbed him to death in revenge for the killing of their cousin more than 12 years ago, as the Public Prosecution played CCTV footage and sought the maximum penalty.

The defendants, aged 25 and 28, told the High Criminal Court they stabbed the victim, who shared their Asian nationality, during the opening session of the trial.

Prosecutors said the men claimed the victim had killed their cousin in their home country years earlier.

Attack

They tracked him for two months, the court heard, before lying in wait close to his residence and carrying out the attack.

Footage played in court showed the first defendant checking the area about 90 minutes before the killing, prosecutors said.

Further recordings captured both men attacking the victim near his home until he fell and died.

The Public Prosecution said the case began after Northern Governorate Police reported finding a body in an alley in Budaiya with multiple stab wounds.

Statements

Investigators examined the scene and took witness state-

ments, which, along with camera recordings, pointed to the two defendants.

Police arrested them as they tried to leave Bahrain, prosecutors told the court

The weapons were later recovered after the defendants led officers to where they had been left.

The men gave detailed confessions during questioning, the court heard, saying the long-running dispute drove them to plan the killing.



The man died from stab and incised wounds in different parts of his body, consistent with the seized weapons.

They described waiting near the victim's home, stabbing him several times, then fleeing.

Stab

A forensic pathologist concluded the man died from stab and incised wounds in different parts of his body, consistent with the seized weapons.

Laboratory tests found the victim's blood and cells on the defendants' clothing and on both weapons, prosecutors said. Proceedings are continuing.

Reckless driver remanded in custody

● Car stunt at major intersection

The Public Prosecutor and Head of the Traffic Prosecution said that the Public Prosecution received a report from the General Traffic Directorate regarding a driver who carried out reckless car stunts at a major intersection in the Northern Governorate, putting his life and the safety of other road users at risk.

The vehicle was circulated for identification, and the driver was later arrested.

Following the report, the Public Prosecution immediately launched an investigation, during which the defendant was questioned and confronted with a video recording of the incident.

The defendant admitted to the charges.

Accordingly, the Public Prosecution ordered the defendant to be remanded in custody pending investigation, in preparation for referring him to criminal trial.

Girl, 8, to get passport after being denied papers since birth

An eight-year-old girl will get her passport and identity card after the High Civil Court ruled she has been a citizen since birth.

The child, born in 2018, had no passport or identity card since birth.

The Court ordered the authorities to hand the documents to her father and record the decision in their registers.

Her parents went to court after their request was not met.

They relied on a Sharia ruling confirming the child's lin-

eage to her father, and a civil judgment ordering the issuance of her birth certificate, but the documents were still not issued.

The case was brought by lawyer Jassim Al Issa, who asked the court to compel the authorities to issue the papers and deliver them to the father.

The defence argued the claim should be thrown out because there was no formal administrative refusal to challenge.

Argument

The judges rejected that argument, saying an administrative decision does not need to

The way the request was han-

dled could only be understood as a refusal, the court found.

It then turned to the law, citing provisions that restrict passports to Bahraini nationals and treat a person as Bahraini if born to a Bahraini father, once lineage is established under Sharia.

Citizenship

On that basis, the court held that citizenship follows from birth and that the child is entitled to a Bahraini passport.

The judgment also referred to the population register and identity card rules, which require individuals to be registered, as-

signed a personal number and issued an identity card containing their identifying and civil details.

The court found the child was born in Bahrain to a Bahraini father, that her lineage had been established and that it was not disputed.

Records

It ruled she is Bahraini by operation of law and entitled to both documents, ordering the authorities to issue them and record the matter in their official records.

The court ordered the family to pay the costs of the case.

‘Poor lighting’ leaves walkways unsafe at night

Members of the Northern Municipal Council raised clear safety concerns over poor lighting along public walkways in Hamad Town, warning that repeated failures leave residents exposed to risk during night time hours.

The issue was discussed during the council's Ordinary Session 11, with members stressing that the problem has remained unresolved despite ongoing complaints.

Abdullah Mubarak Bilal Al Qubaisi and Abdullah Al Thawadi said that lighting units installed along the walkways often stop working after midnight due to preset timers.

Darkness

As a result, residents who walk or exercise at night are forced to move in near darkness.

Members also noted that the lights frequently fail during

rainy weather or stop working without warning.

The council heard that maintenance is often slow, with some lighting faults taking weeks or even months to be repaired.

Members pointed out that some companies responsible for maintenance do not have

sufficient spare parts available locally, which causes long delays and leaves walkways unlit for extended periods.

Impact

Members stressed that the issue goes beyond inconvenience. Poor lighting affects public

safety, particularly for families, elderly residents and women who use the walkways in the evening.

Several areas were described as becoming unsafe and unwelcoming after dark, discouraging residents from using public spaces meant to promote healthy lifestyles.

Northern Council moves to address growing needs at Budaiya Cemetery

The Northern Municipal Council has raised concerns over the growing needs of Budaiya Cemetery, stressing the importance of urgent co-ordination between relevant authorities to ensure the site continues to serve the community in a dignified and organised manner.

The issue was discussed under the “Other Business” agenda during the council's Ordinary Session 11.

Members highlighted that

the cemetery is facing increasing pressure due to population growth in surrounding areas, creating a need to review capacity, maintenance requirements and overall readiness.

Councillors stressed that cemetery services are a sensitive matter closely linked to public dignity, religious practices and community wellbeing, and should therefore be addressed without delay.

The council will raise an official letter to the Minister of Municipalities Affairs and Agriculture, requesting coordination with the Justice Minister.

Urgent call made to fix Hamad Town public toilets

● Projects remain unfinished despite repeated complaints from community

Persistent problems affecting public toilets in Hamad Town were brought back to the forefront during the Northern Municipal Council's Ordinary Session 11, as members criticised long delays, poor maintenance and limited access to facilities used daily by residents and visitors.

Abdullah Mubarak Bilal Al Qubaisi led the intervention, questioning why projects discussed years ago remain unfinished despite repeated complaints from the community.

Council members highlighted that plans to upgrade and open new public toilets date back to 2016, yet progress remains unclear, with some timelines extending as far as 2029.

Al Qubaisi said residents continue to rely on ageing facilities that frequently close or operate for limited hours, forcing people to endure unnecessary hardship, particularly during busy periods and public events.

Issues

Members cited damaged doors, leaking water, worn fittings and poor hygiene as recurring issues.

Concerns were also raised over wasted water, outdated plumbing and a lack of regular supervision.

Several speakers noted that the toilets operate for only 12 hours a day, despite constant public use, while the shortage of guards has allowed neglect and misuse to persist.

Fast track completion of Budaiya Health Centre: Council

The Northern Municipal Council renewed its pressure to accelerate the completion of the Budaiya Health Centre, warning that continued delays strain healthcare services and residents in surrounding areas.

The issue was raised under the "Other Business" agenda during the council's Ordinary Session 11, following a proposal submitted by council member Mohammed Saad Al Dossary.

Council members learned that the existing Budaiya clinic is under significant pressure, serving an estimated 7,500 patients monthly.

The facility serves several residential areas, including Budaiya and nearby villages, making it one of the busiest primary healthcare points in the Northern Governorate.

Public health first

Northern Municipal Council backs Hamad Town sewage upgrade to end foul smells

The Northern Municipal Council has approved a proposal to upgrade the sewage pumping station on Road 1650 in Block 1216 in Hamad Town after repeated complaints about foul odours, with a residents' petition attached to the proposal.

The plan was put forward by council member Abdulla Al Thawadi and cleared at the council's meeting on Monday.

He said: "We have received repeated complaints from residents about foul odours coming from the station, causing disturbance and affecting their quality of life."

Demand

Al Thawadi said some parts of the station were ageing and needed maintenance or replacement, while higher demand from housing growth had added to the operating load.

He said the work was aimed at tackling the smell problem and improving the service, adding: "We want to reduce the odours

and treat their causes at the root, raise the station's operating efficiency, and improve the level of service provided to residents."

The proposal describes the sewage system as core public infrastructure, with a direct link to public health and the surrounding environment.

Facility

It says the station, described as an important service facility

in Hamad Town, needs work in light of operational notes, complaints from residents and the petition.

It calls for updating existing systems to improve performance and raise capacity so the station can handle higher volumes as Block 1216 grows.

The proposal also calls for steps to meet approved environmental and health requirements, and to improve the quality of

treated water so it meets local and international standards before discharge.

Technology

The proposal also refers to using modern technology to cut pollution linked to the station and support environmental sustainability, including reusing treated water for non-drinking purposes to help conserve water resources.

It also calls for better maintenance routines and training for staff to cut faults, reduce service stoppages and keep the station running more reliably.

Council backs reopening of garbage bag offices

● Move to resolve long-running crisis affecting residents

Calls to reopen garbage bag distribution offices dominated the Northern Municipal Council's Ordinary Session 11, as members warned that existing measures have failed to resolve a long-running crisis

affecting residents across the governorate.

Abdullah Mubarak Bilal Al Qubaisi, Saad Al Dossary, Bassem Abu Idris and Abdullah Ashour expressed shared concern that the Ministry has yet to demonstrate sufficient seriousness in addressing the issue, particularly in high density areas such as Madinat Hamad.

Members challenged official claims that distribution machines operate 24 hours a day, noting that many are located inside complexes that close at midnight and remain shut on

Fridays and Saturdays.

In several locations, only two machines are available to serve large populations, with frequent malfunctions further restricting access.

Saad Al Dossary revealed that a home delivery service for elderly residents had previously been in place but was later cancelled, leaving many without support.

Council members stressed that a significant number of senior citizens are unable to use electronic machines in the first place, effectively excluding

them from the service.

They argued that reopening distribution offices is no longer optional but necessary, at least until sufficient and reliable alternatives are available.

The council highlighted that the problem dates back to 2020, despite repeated assurances since 2022 that additional machines would be deployed.

Members also questioned why office services remain open in other governorates, while residents in the Northern Governorate continue to face closures.

Firm action sought on workers housing in family neighbourhoods

The Northern Municipal Council has moved to confront the growing issue of workers being housed within family residential areas, warning that the situation now carries social and safety implications that can no longer be overlooked.

The matter was raised during the council's Ordinary Session 11, where members agreed that the spread of unregulated accommodation requires coordinated and decisive intervention.

Council member Mohammed Saad Al Dossary outlined the scale of the problem, pointing to increasing complaints from residents over overcrowding, unauthorised subletting and the erosion of the social character of neighbourhoods.

Some properties are being used in clear violation of regulations, with occupants sharing homes originally designated for single families.

Environmental awareness workshop

The Supreme Council for Environment, in coordination with the Ministry of Social Development, organised a workshop titled "We Bring It Back to Revive It... In Our Homes," targeting social centres. The initiative comes as part of joint efforts to enhance environmental awareness and promote proper waste management practices across the community. The event was attended by Mr Ziad Adel Darwish, Undersecretary of the Ministry of Social Development.

Russia sells fourth-biggest airport seized in nationalisation bid

One of Russia's biggest airports, Moscow's Domodedovo, has been re-privatised and sold to a managing company of the country's busiest airport, Sheremetyevo, the buyer said yesterday.

In June, a Russian court ruled ownership of Domodedovo, the nation's fourth-busiest, be nationalised and transferred to the state.

It found that its two owners, Dmitry Kamenshchik and Valery Kogan, were foreign residents who had no right to manage the infrastructure asset.

Sheremetyevo, "represented by its wholly owned subsidiary Perspektiva LLC, and Bank PSB PJSC announce the signing of an agreement for the sale of Domodedovo Airport," it said

in a press release.

The airport was sold at the second attempt for about \$850 million -- almost half the initial asking price of \$1.6 billion.

Sheremetyevo is majority-owned by the private company TPS Avia Holding and the Russian government, which holds a 30-percent stake, according to the Russian business outlet RBC.

TPS Avia Holding was moved back from Cyprus to Russia in 2022, and the Russian media mentioned Arkady Rotenberg, a close associate of President Vladimir Putin, among the shareholders of the firm.

Billions of dollars' worth of assets have been confiscated by the Russian state since Russia sent troops into Ukraine in 2022, including those belonging to Western firms.

US forces seize ship in Indian Ocean that fled Caribbean blockade

US forces boarded and seized an oil tanker in the Indian Ocean that violated President Donald Trump's blockade of sanctioned vessels in the Caribbean and fled the region, the Pentagon said yesterday.

The Pentagon told AFP that US forces had seized the ship, after announcing on X that the Aquila II was boarded "without incident" overnight.

The tanker "was operating in defiance of President Trump's established quarantine of sanctioned vessels in the Caribbean-



an. It ran, and we followed," the Pentagon said on X, adding that the vessel was "tracked and

hunted" from the Caribbean to the Indian Ocean.

The post included a video of

US forces boarding a helicopter and then roping down onto the deck of a tanker ship.

The ship is the eighth seized by the United States since Trump in December ordered a "blockade" of sanctioned oil vessels heading to and from Venezuela.

And it is the second to lead US forces on a chase outside the region, after a Russia-linked tanker was apprehended in the North Atlantic last month after being pursued by the United States from off the coast of Venezuela.

EU warns Meta it must open up WhatsApp to rival AI chatbots

The EU executive told Meta yesterday that it must let rival AI chatbots use its WhatsApp platform, after an antitrust probe found the US giant to be in breach of the bloc's competition rules.

The European Commission said a change in Meta's terms had "effectively" barred third-party artificial intelligence assistants from connecting to customers via the mes-

saging platform since January.

Competition chief Teresa Ribera said the EU was "considering" interim measures to "avoid Meta's new policy irreparably harming competition in Europe".

The EU executive sent Meta a warning known as a "statement of objections", a formal step in antitrust probes, and the US giant now has a chance to reply and defend itself.

News in brief

◆ **China yesterday** denied US allegations it had conducted secret nuclear explosive tests, calling them “outright lies” and accusing Washington of making excuses to start up its own trials. At the UN Conference on Disarmament in Geneva on Friday, Thomas DiNanno, US under secretary of state for arms control accused China of conducting the tests, including one on 22 June 2020, and of preparing for more tests with massive yields. “The US allegations are completely groundless and are outright lies. China firmly opposes the US attempt to fabricate excuses for its own restarting of nuclear tests,” China’s ministry of foreign affairs said in a statement to AFP on Monday. It also urged the United States to “immediately stop its irresponsible actions”. US President Donald Trump said in October that Washington would start testing nuclear weapons “on an equal basis” with Moscow and Beijing, but without elaborating or explaining what kind of nuclear testing he wanted to resume.

◆ **Sydney police** used pepper spray on protesters yesterday as a rally against a visit to Australia by Israel’s President Isaac Herzog turned violent. The head of state’s tightly secured, four-day visit was aimed at consoling Australia’s Jewish community in the wake of the December shooting at Sydney’s Bondi Beach that killed 15 people at a Hanukkah festival. But he was met with protests in Australia’s two largest cities on Monday evening, with a Sydney rally turning violent as police hit protesters and members of the media, including AFP, with pepper spray. An AFP journalist said they saw at least 15 protesters being arrested as members of the rally scuffled with the police. Palestine Action Group spokesman Josh Lees said on Instagram the police had “repeatedly charged us with horses and pepper spray”. New South Wales police declined to comment when contacted by AFP.

◆ **A Lebanese Islamist** group accused Israel yesterday of abducting one of its members during a cross-border raid in the country’s south, as Israel dubbed the suspect a “senior terrorist”. Israel frequently carries out military operations in southern Lebanon despite a November 2024 ceasefire aimed at ending more than a year of hostilities with militant group Hezbollah. It launches air strikes and occupies five points on Lebanese territory that it deems strategic. On Monday, the Jamaa Islamiya group, an ally of Palestinian Hamas, accused Israel of seizing one of its officials, Atwi Atwi, from his home in the Hasbaya district and taking him to an unknown location. Jamaa Islamiya, which has claimed responsibility for multiple attacks against Israel during the war with Hezbollah, condemned “the Israeli occupation forces’ infiltration”.

Brain training reduces dementia risk by 25%, study finds

Researchers announced on Monday that a randomised controlled trial -- considered the gold standard for medical research -- has finally identified something capable of significantly lowering people’s risk of developing dementia.

And rather than an expensive drug, it was a cheap and simple brain-training exercise that was found to decrease dementia rates by a quarter, according to the study.

“For the first time, this is a gold-standard study that’s given us an idea of what we can do to reduce risk for developing dementia,” study co-author Marilyn Albert of Johns Hopkins University in the United States told AFP.

Although there are a vast amount of brain-training games and apps which claim to fight off cognitive decline, there has been little high-quality, long-term research proving their effectiveness.

The US team of researchers warned that their study -- which only found one specific type of training made a difference -- does not mean that all brain-training games are effective.

tive.

Their trial, called ACTIVE, began in the late 1990s.

More than 2,800 participants aged 65 or older were randomly assigned one of three different types of brain training -- speed, memory, or reasoning -- or were part of a control group.

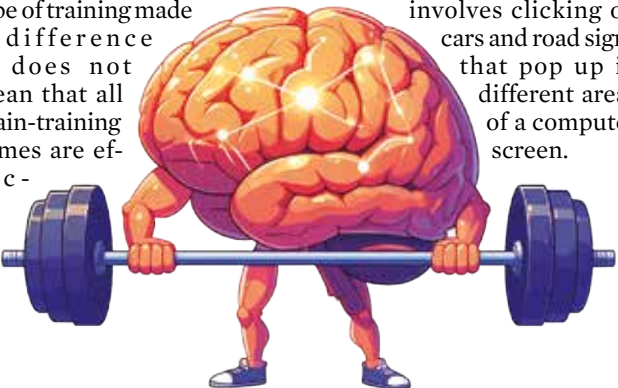
First, the participants did an hour-long training session twice a week for five weeks. One and three years later, they did four booster sessions. In total, there were fewer than 24 hours of training.

During follow ups after five, 10 and most recently 20 years, the speed training was always “disproportionately beneficial”, Albert said.

After two decades, Medicare records showed that the people who did the speed-training and booster sessions had a 25-percent reduced risk of getting dementia.

The researchers were surprised to find that the other two types of training did not make a statistically significant difference.

The speed training exercise involves clicking on cars and road signs that pop up in different areas of a computer screen.



Eight countries condemn Israel’s ‘illegal’ West Bank control measures

New measures allow Jewish Israelis to buy West Bank land

● **Envisages transferring authority in parts of Palestinian cities over building permits to Israel**

● **More than 500,000 Israelis live in settlements and outposts in the West Bank**

Saudi Arabia and seven other Muslim-majority countries yesterday condemned new Israeli measures to tighten control of the West Bank and pave the way for more settlements in the occupied Palestinian territory.

Israel approved the measures, announced by Finance Minister Bezalel Smotrich and Defence Minister Israel Katz, on Sunday. They include allowing Jewish Israelis to buy West Bank land, a joint statement from the ministers said.

The foreign ministers of Saudi Arabia, Jordan, the UAE, Qatar, Indonesia, Pakistan, Egypt and Turkey “condemned in the strongest terms the illegal Israeli

decisions and measures aimed at imposing unlawful Israeli sovereignty”, a Saudi statement said.

They are an attempt at “entrenching settlement activity, and enforcing a new legal and administrative reality in the occupied West Bank, thereby accelerating attempts at its illegal annexation and the displacement of the Palestinian people”, the foreign ministry statement added.

The Israeli measures also envisage transferring authority

over building permits for settlements in parts of Palestinian cities, including Hebron, from the Palestinian Authority’s municipalities to Israel.

Smotrich said the move was aimed at “deepening our roots in all regions of the Land of Israel and burying the idea of a Palestinian state”.

The Palestinian presidency in Ramallah, which exercises limited control over some discontinuous areas of the West Bank, also condemned the decision, saying

it was aimed at “deepening attempts to annex the occupied West Bank”.

The announcement comes days ahead of Israeli Prime Minister Benjamin Netanyahu’s visit to the United States, where he is due to meet President Donald Trump, who has upheld US opposition to Israeli annexation of the West Bank.

Around three million Palestinians live in the territory. Another 200,000 Israelis live in Israeli-annexed east Jerusalem, which the UN says is part of the Palestinian territories.

Norway launches probe of diplomat and husband over Epstein links

Norwegian police said yesterday they had launched a corruption investigation into a high-profile diplomat, Mona Juul, and her husband Terje Rod-Larsen as an accomplice, over the couple’s links to late US sex offender Jeffrey Epstein.

The police economic crime



unit Okokrim said in statement the probe began last week and that an Oslo residence was searched on Monday, as well as a residence belonging to a witness.

“We have launched an investigation to determine whether any criminal offences have been committed. We are facing a comprehensive and by all accounts

lengthy investigation,” Okokrim chief Pal Lonseth, said. Juul was head of section at Norway’s foreign ministry before becoming Norway’s ambassador to the UK during the 2010s. Juul, 66, and Rod-Larsen, 78, played key roles in the secret Israeli-Palestinian negotiations which led to the Oslo Accords of the early 1990s.

Prince William, Kate ‘deeply concerned’ by latest Epstein revelations: spokesman

Prince William and his wife Catherine have been “deeply concerned” by the latest revelations linking William’s uncle Andrew Mountbatten-Windsor to late US sex offender Jeffrey Epstein, Kensington Palace said yesterday.

“I can confirm that the Prince and Princess of Wales have been deeply concerned by the continued revelations,” the palace said in a statement.

It added that “their thoughts remain focused on the victims” of Epstein, who died in prison awaiting trial on sex trafficking charges in 2019.

The statement was the first public comment from the heir to the throne and his wife on the scandal since the latest release of Epstein files more than a week ago and as the monarchy faces scrutiny over the scandal.

It follows a renewed furore

over Andrew’s close links to Epstein, with King Charles III’s brother under pressure to further explain them.

Andrew stepped back from royal duties in 2019 over the ties and following claims by Epstein accuser Virginia Giuffre that

she was trafficked to have sex with the disgraced royal three times, including twice when she was 17.

King Charles III stripped his brother of his royal titles and honours late last year after Giuffre recounted the claims in

shocking detail in a posthumous memoir.

Last week it emerged a second alleged Epstein victim has claimed through her lawyer that the late US financier had sent her to Britain in 2010 to have sex with Andrew.

The ex-prince, who has strenuously denied any wrongdoing, was ousted from his Windsor mansion home, just west of London, earlier than planned last week in the wake of the latest revelations.

The files released in the US included newly-damaging evidence, including a lawyer’s letter alleging that Andrew and Epstein pressured a woman hired as an exotic dancer for sex as part of a threesome in 2006.

They also contained embarrassing photos of Andrew kneeling over a clothed woman lying on the ground, and emails inviting Epstein to Buckingham Palace to talk in “private”.

Japan PM Takaichi basks in historic election triumph

Takaichi's LDP won a two-thirds majority

● Japan's first woman prime minister

● She had said Japan could intervene militarily if Beijing sought to take Taiwan by force

Japanese premier Sanae Takaichi said yesterday that the public saw an "urgent need" for major reform after a historic election landslide, pledging to boost the country's defences in order to protect its territory.

Sunday's snap vote saw Takaichi's Liberal Democratic Party (LDP) win a two-thirds majority in the lower house for the first time in its history, capitalising on her strong popularity since taking office in October.

The outcome allows Japan's first woman prime minister to stamp her mark on the country of 123 million people over the next four years, having pledged to boost the economy and get tough on immigration.

"This is the start of a heavy, heavy responsibility to make Japan stronger, more prosperous," Takaichi, 64, told a news conference on Monday.

"We believe that the public has shown understanding and sympathy regarding our appeals concerning the urgent need for a major policy shift," she said.

The admirer of "Iron Lady" Margaret Thatcher also said she would bolster Japan's defences, including through creating a new intelligence bureau and revising key security policy documents.

Honeymoon

Capitalising on her honeymoon start after becoming Japan's fifth premier in as many years in October, Takaichi called the snap election last month.

The gamble paid off, with the LDP winning around 316 of the 465 seats contested, according to Japanese media.

That takes the party past the 310-seat threshold needed for the first time in its history and may prompt the government to try and make changes to the country's constitution. US President Donald Trump -- who is due to host Takaichi in Washington next month -- congratulated her after an earlier endorsement.

"I wish you Great Success in passing your Conservative, Peace Through Strength Agenda," Trump wrote on Truth Social.

US vice president visits Armenia, Azerbaijan to 'advance' peace

US Vice President JD Vance arrived in Armenia yesterday, before a scheduled trip to Azerbaijan, as Washington seeks to consolidate a peace process between the neighbours.

Vance is the most senior US official to visit Armenia, where he is also expected to advance a flagship project to improve road and rail infrastructure in the region.

His visit to Armenia -- until

recently a close Russia ally -- comes as Moscow's influence has dwindled in the region since its 2022 invasion of Ukraine.

At a White House summit in August 2025, US President Donald Trump brokered an agreement between Armenia and Azerbaijan that saw the two countries commit to renouncing claims on each other's territory and refrain from using force.

The United Nations rights chief deplored Monday the 20-year-sentence handed to Hong Kong pro-democracy media tycoon Jimmy Lai, demanding that the verdict be "promptly quashed".

Lai, a British citizen and founder of the now-defunct Apple Daily newspaper, was found guilty in December of

urging foreign countries to impose sanctions on Hong Kong and for publishing "se-

ditious" articles in his paper. On Monday, a Hong Kong court handed down the harshest penalty yet under a Beijing-imposed national security law.

"Jimmy Lai is a publisher sentenced to 20 years in prison for exercising rights protected under international law," UN High Commissioner for Human Rights Volker Turk said in a statement.

Bahrain Brings Alternative Healthcare into the Mainstream

Interest in alternative and complementary healthcare has grown worldwide, driven by a shift towards preventive, lifestyle-based and holistic approaches to well-being. Practices such as acupuncture, herbal medicine, yoga and mindfulness are now widely used across the United States, Europe and Asia. Global health bodies, including the World Health Organization, have encouraged governments to regulate and integrate these practices into national health systems to improve safety, quality and patient care.

This global trend is increasingly visible in Bahrain. As lifestyle-related conditions such as diabetes, obesity and cardiovascular disease become more prevalent, more residents are exploring alternative therapies alongside conventional medical care. Recognising this shift early, the Government of Bahrain has adopted a structured and forward-looking approach, bringing alternative healthcare into the national health framework through regulation, licensing and policy oversight.

Alternative healthcare is not new to Bahraini society. Traditional practices such as hijama (cupping) and herbal remedies have long been part of community health traditions. What has changed in recent years is the way these practices are governed and professionalised. In 2016, the government established a legal foundation for regulating alternative and complementary medicine, signalling a clear policy choice to move the sector out of informality and into a supervised healthcare environment.

The National Health Regulatory Authority (NHRA) has since played a central role in implementing this vision. Through licensing requirements, verification of professional qualifications and regular facility inspections, the authority ensures that alternative healthcare services meet acceptable safety and quality standards. Practices such as hijama, acupuncture, Ayurveda, traditional Chinese medicine, chiropractic care, homeopathy and therapeutic massage are now subject to the same regulatory discipline expected of other health services. This framework protects patients while allowing credible practitioners to operate transparently.

Crucially, government policy positions alternative healthcare as complementary to modern medicine, not a replacement for it. Conventional medical treatment remains central to Bahrain's healthcare system, with alternative therapies encouraged as supportive options where appropriate. This distinction has helped prevent unrealistic claims while encouraging coordination between patients, physicians and licensed alternative practitioners. The emphasis remains firmly on evidence, transparency and informed choice -- principles that protect patients while respecting cultural and personal preferences.

Bahrain has also invested in capacity building and international cooperation. Health authorities have engaged with countries that have long-standing traditional medicine systems, particularly India and China, to study best practices in training, certification and clinical governance. These exchanges have helped shape licensing standards suited to Bahrain's healthcare environment while maintaining international credibility.

Beyond health outcomes, the regulated integration of alternative healthcare supports wider national goals. It contributes to Bahrain's Vision 2030 focus on quality of life, preventive care and service-sector diversification. Properly regulated wellness services also enhance the Kingdom's appeal as a destination for medical and wellness tourism, while creating professional opportunities within the health sector.

Challenges remain, particularly in addressing misinformation and discouraging unlicensed practice. However, Bahrain's regulatory framework provides a strong foundation to address these concerns over time.

By choosing regulation over restriction and integration over neglect, Bahrain has demonstrated a balanced and forward-looking approach. As global interest in holistic health continues to rise, the Kingdom's policies ensure that alternative healthcare evolves as a credible, well-governed component of its modern healthcare system.

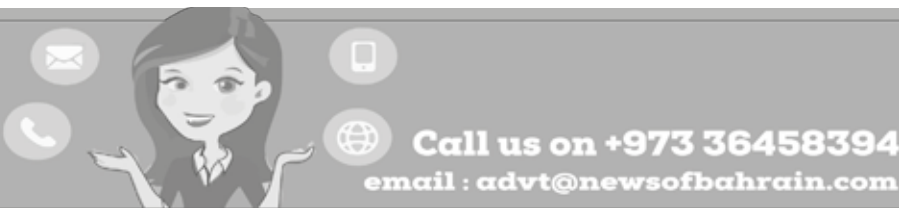

LaLiga 'light years' behind Premier League, complains Cazorla

Real Oviedo midfielder Santi Cazorla complained Spain's LaLiga is a long way behind the Premier League on Sunday, a day after his team's match at Rayo Vallecano was postponed at short notice.

Oviedo's visit to Rayo's Vallecas Stadium on Saturday was called off hours before the game with LaLiga explaining the conditions were not safe for the players because of the state of the recently-laid pitch.

"The reality is LaLiga is light years behind the Premier League in every sense," wrote former Arsenal playmaker Cazorla on social media.

Rayo players protested

against their own club on Friday in a statement calling for improvements at Vallecas and better treatment of their fans.

On Sunday, Oviedo called on the Spanish football federation (RFEF) to declare them winners of the match, yet to be rescheduled, although the request is widely considered unlikely to be successful.

'I need to improve', says Haaland after barren spell

Erling Haaland said tiredness was no excuse for his poor goalscoring run in 2026 as he demands more of himself to keep Manchester City in the hunt for four trophies.

Haaland scored a dramatic stoppage-time winner from the penalty spot as City beat Liverpool 2-1 on Sunday to remain six points behind Arsenal in the Premier League title race.

The 25-year-old has netted 28 times in 36 games for City this season.

But he has not scored from open play in the Premier League since December 20 and has just three goals in his last 13 appearances.

"Of course, I haven't scored enough goals since the start of this year and I know that I need to improve," said the Norwegian.

"I know I need to be more sharp, better at all of this, and this is something that I have to work on.

"I have to keep going because this is what everyone deserves and expects."

Pep Guardiola said last month that Haaland was "exhausted" by a gruelling schedule with City still involved in four competitions.

Guardiola's men will face Arsenal in the League Cup final next month, are into the last 16 of the Champions League, and face fourth-tier Salford in the fourth round of the FA Cup.

"I don't want to speak about why I haven't performed. I don't think there's any excuse. Fatigue is a lot in the head," added Haaland.

"It's a lot of games. Look at

the schedule, it's not easy and for me, it's about staying fit, that's the most important thing, and trying to be ready to help the team."

City looked set to fall nine points behind Arsenal at the top of the table until a chaotic finale

at Anfield.

The visitors trailed to Dominik Szoboszlai's brilliant free-kick with just six minutes of normal time remaining until Haaland teed up Bernardo Silva to level.

Haaland then kept his cool in a frenzied atmosphere from the spot to rekindle City's hopes in the title race.

They can ramp up the pressure even more on Arsenal with victory over Fulham on Wednesday to halve the deficit at the top before the Gunners face Brentford 24 hours later.

"We've seen before that the title race is not over until it's over," said Haaland.

"Right now I need to focus on Fulham because there's still many games (to go)."

Bahrain's golden girl strikes again

Winfred Yavi wins 6km cross-country race in Sardinia, Italy

Bahrain's Olympic champion Winfred Yavi delivered another exceptional performance on the international stage, winning the women's 6km race at the Cross di Alà dei Sardi – Memorial Elisa Migliore in Sardinia, Italy, on Sunday. Competing in her second race of the season, Yavi crossed the line in 20:37, well ahead of Burundi's Francine Nyomukunzi (21:40) and Britain's Emily

Grace Collinge (22:21). From the opening metres on the rolling Coiluna course, Yavi took control. She quickly settled into a strong rhythm, forcing Nyomukunzi to chase. By the midpoint, Yavi had opened daylight on her rivals. She maintained her form through the final kilometre and powered across the finish line unchallenged. The victory confirmed Yavi as the standout athlete in a field packed with experienced European and international compet-

itors. At 26, she is ranked #2 in the world in the 3000m steeplechase. Her career highlights include Olympic gold in Paris 2024, a World Championship title, a Diamond League Final win, and a World Championships silver medal. Her latest success in Italy marks a strong start to the season and signals what's ahead for Bahrain's star sprinter. Yavi's performance in Sardinia also demonstrates her readiness for the months ahead. Yavi will next compete at the World

Military Cross Country Championships in Trikala, Greece, starting February 25. Later in the year, she will focus on the Asian Games in Nagoya, Japan, in September. The Cross di Alà dei Sardi is one of Italy's most prestigious cross-country events, attracting elite runners from across Europe and beyond. Yavi's win adds another high-profile chapter to the race's history and highlights the Kingdom's rising influence on the global athletics stage.

Scotland spoil Italy's T20 World Cup debut with big win

T20 World Cup debutants Italy had a bruising introduction to cricket's biggest stage as they suffered a crushing 73-run loss to Scotland yesterday in Kolkata. Off-spinner Michael Leask took 4-17 for Scotland, adding to his batting cameo of an unbeaten 22 off five balls. A nation better known for its football, Italy are the lowest-ranked side in the 20-team tournament and were making a slice of history here. Chasing a mammoth 208 for victory, they suffered early blows before a valiant fourth-wicket partnership of 73 between Australia-born brothers Ben and Harry Manenti kept them afloat at Eden Gardens. But Harry departed for 37 and

Howe would 'step aside' if right for Newcastle

Eddie Howe said yesterday he would resign if he felt it was the best thing for Newcastle after a dismal run that has dropped the Magpies down to 12th in the Premier League.

But Howe vowed to "work better" and "do more" after his side were booed off following a 3-2 home defeat to Brentford

"That's why I'm sat here. If there was, then I wouldn't be because, as I said, the club is the most important thing.

"I'd never put myself before the club. If I didn't think I was the correct man to take the team forward and I could give the players what they need, then I would step aside and let someone else do it."

Kuwait Club Ends Muharraq Super League Run

Muharraq's FIBA West Asia Super League campaign ended last night with a 78-69 loss to Kuwait SC at the BBA Arena in Umm Al Hassam.
