GCC Steps Up Anti-Corruption Cooperation



Bahrain led discussions on strengthening Gulf cooperation in the fight against corruption, with senior officials from GCC member states reviewing joint efforts to promote integrity and transparency.

Brigadier General Ahmed Saad Al Rumaihi, Director General of the General Directorate of Anti-Corruption and Economic and Electronic Security at the Ministry of Interior. The event focused on international experiences in promoting integrity and transparency in sports.

The meeting further reviewed the results of the second GCC Research and Studies Competition in the fields of integrity protection and combating corruption.

Other discussions covered the GCC Joint Anti-Corruption Strategy, efforts to strengthen integrity and compliance in the private sector, and cooperation with the International Anti-Corruption Academy.

The meeting also served as preparation for the 12th meeting of the GCC Ministerial Committee Responsible for Combating Corruption. Officials discussed the issues and recommendations to be referred to the ministerial committee for consideration and appropriate action.

Protests Erupt in Syria Over Fuel Price Hikes

Protests broke out in parts of Syria on Sunday following the government's decision to increase fuel prices, with demonstrators blocking roads and calling for the measures to be reversed amid rising living costs.

In the Aleppo countryside, protesters gathered in Azaz and Al-Bab, chanting against the price increases and closing roads. Demonstrators also blocked the M5 international highway near Maarat al-Nu'man in southern Idlib, with footage showing burning tyres on the road.

The protests came a day after Energy Minister Mohammed al-Bashir said the price increase was necessary to narrow a temporary gap between the cost of import-



ing petroleum products and domestic selling prices.

Al-Bashir said Syria currently produces about 102,000 barrels of oil per day, compared with domestic demand of around 325,000 barrels, forcing the country to rely heavily on imports.

The Energy Ministry said it would continue reviewing fuel prices in line with global market changes while working to expand refining and storage capacity.

IAEA Supervises 73 Tonnes of Uranium in Syria

The International Atomic Energy Agency (IAEA) is supervising 73 tonnes of natural uranium in Syria in coordination with Syrian authorities, Foreign Minister Asaad Hassan Al-Shaibani said. Speaking to the IAEA General Conference, he welcomed the agency's decision to end a long-running investigation into Syria's undeclared nuclear activities. IAEA inspectors

visited Deir Ezzor in August and found evidence of a nearly completed reactor, which was destroyed by Israeli airstrikes in 2007. Syrian and IAEA experts are removing reactor remnants from the site. Al-Shaibani said the decision restored Syria's standing under the Nuclear Non-Proliferation Treaty. Syria and the IAEA also agreed on peaceful nuclear cooperation.
