Price stability

Ramadan staples to be cut by at least 38% as ministry warns repeat offenders

At least 38 per cent off key Ramadan staples will be enforced across Bahrain's markets, Industry and Commerce Minister, His Excellency Abdulla Fakhro, told Parliament yesterday, saying the ministry aims to keep prices stable and will take tougher legal steps against repeat offenders.

"We are keen to ensure price stability during the holy month of Ramadan," he said, adding that the kingdom has enough stock of essential goods and that discounts are already available across markets.

Fakhro said the ministry is urging shops and suppliers to keep Ramadan goods at suitable prices and to stick to set reductions for the full month through schemes such as the "Consumer

Friend" initiative.

Amendments

He said the ministry is working on its legal tools and is studying amendments to the Consumer Protection Law to keep pace with shifts in the market.

"Consumer protection is a priority," he said, pointing to programmes aimed at all age groups and closer work with the private sector.

Part of that work, he said, includes signing memoranda of understanding with major

service providers so complaints can be dealt with before they reach the ministry.

Cases

The aim is to solve cases "before escalating them to the min-

istry", he said.

Fakhro said awareness drives are being run with government bodies, including the Ministry of Youth, the Ministry of Education and universities, to raise awareness of consumers' rights and duties.

Eight held for selling expired food products

The Head of the Prosecution for Ministries and Public Entities announced that the Public Prosecution is investigating a case involving the possession and sale of expired food products after altering their expiry dates.

Eight defendants have been remanded in custody pending investigation.

Authorities also ordered the closure of the company's warehouse and several of its affiliated retail outlets.

The case began after a report was received indicating that a company was storing expired food items at a warehouse in Hamala, where expiry dates

were being changed and products repackaged for resale in the market.

Raid

Inspection teams from the Ministry of Industry and Commerce and the Ministry of Health raided the warehouse and seized expired food products that had been repackaged and relabeled for distribution. The Public Prosecution questioned the suspects and ordered their detention pending further investigation.

Authorities have also tasked officials with inventorying the seized goods and identifying any similar products in circulation. Investigations are ongoing ahead of referring the case to criminal court.

Court ruling set for forced labour case

The First Major Criminal Court has set March 31 to issue its ruling in the case of an Asian man accused of exploiting a woman in her twenties by forcing her to work in homes without paying her wages and detaining her in an apartment without electricity, food, or water.

According to the 24-year-old victim, she came to Bahrain as a domestic worker.

The defendant brought her and sent her to work in sever-

al houses without paying her salaries, under his supervision.

Assault

She stated that when she told the defendant she wanted to stop working and return to her home country, he detained her in different buildings and assaulted her by slapping her on the face. He also deprived her of food.

The accommodation had no electricity.

She explained that he did this to force her to change her mind and to obtain money from her.

Ramadan cannon brings delight for children and nostalgia for adults

In the Kingdom of Bahrain, the arrival of the Holy Month of Ramadan is announced by a sound that goes beyond the ears — it touches the heart.

The Iftar Cannon has become a beloved symbol of Ramadan, deeply embedded in the spiritual charm and warm, communal atmosphere that define the Kingdom.

It is more than just a signal; it is a source of delight for children and a nostalgic reminder for adults.

The story of the Ramadan cannon in Bahrain is a journey through time, stretching back to the 1930s.

Echoes

Its first echoes rang out from the historic Port of Manama, where it served as an important communal clock, uniting people around the rhythm of daily life.

As the Kingdom grew, so did this cherished tradition. What began at a single seaside location eventually expanded to all four governorates Capital, Muharraq, Northern, and Southern ensuring that the cannon's thunderous announcement reaches

every corner of the community.

The firing of the cannon follows a precise and celebratory protocol, eagerly anticipated by the public.

Each shot carries its own significance: eight shots mark the official start of Ramadan after the Maghrib prayer, a single shot signals Iftar each evening, and another marks Imsak, the start of the pre-dawn fast.

Farewell

The tradition reaches its crescendo at the month's end, with eight shots fired upon sighting the Eid crescent to bid farewell to Ramadan, followed by a final eight-shot salute on Eid Al-Fitr to celebrate the festival.

While this practice has disappeared in many parts of

the world, Bahrain has preserved it as a living piece of Arab and Islamic cultural heritage.

Even in the age of digital clocks, the deep, resonant sound of the cannon remains the most authentic way to bring the community together, connecting past and present in a shared celebration of faith and tradition.

‘Curb fake investment schemes’

Parliament approved an urgent proposal calling for firmer steps to protect people in Bahrain from fraud carried out under the cover of "investment" and money-placement schemes, after a rise in recent promotions for financial ventures and market speculation.

The proposal urges action to protect personal savings and strengthen economic security, warning that some of the

schemes being sold to the public could be fictitious or amount to scams.

It was submitted by MP Bader Al Tameemi, with the participation of MP Dr Ali Al Nuaimi, MP Ali Saqer Al Doseri, MP Hassan Ebrahim and MP Abdulhakim Al Sheno. In their stated reasons, the MPs said the spread of such practices could damage Bahrain's reputation and economic standing, harm the investment climate and pose a risk to the wider economy, while leaving citizens' savings exposed.

VAT exemption bill for BD600 earners set for review

A proposed VAT exemption for Bahrainis earning under BD 600 a month was sent back to committee yesterday for further study, after the government asked Parliament to reconsider the measure.

MPs agreed to return the draft law to the Financial and Economic Affairs Committee, halting its progress in the chamber while members revisit how the

exemption would work in practice and whether the income threshold is fit for purpose.

The bill, in its committee-amended form, would exempt low-income Bahrainis from value added tax and defines the eligible group as Bahraini natural persons whose gross monthly income is less than BD600, with the word 'gross' added to tighten the definition.

The draft consists of three articles alongside its preamble.

Article 1 states that people in that bracket are exempt from VAT.

Decisions

Article 2 authorises the Minister of Finance and National Economy to issue the decisions needed to implement the law.

Article 3 contains the standard implementation clause, assigning execution to the Prime Minister and ministers and providing for the law to take effect the day after publication in the

Official Gazette.

Even before the decision to return it to committee, much of the debate had focused on the number at the heart of the proposal and on the lack of a single national standard for who counts as low income.

Dr Ali Al Nuaimi urged MPs to ensure any exemption can be applied in practice, arguing the discussion had exposed differences between government bodies in how the category is defined.

Road ownership and zoning adjustments

The Muharraq Municipal Council approved a set of proposals concerning road ownership and zoning adjustments as strategic urban planning and regulatory clarity took centre stage during the Twelfth Ordinary Meeting of the Sixth Municipal Session.

Among the approved matters was a formal inquiry into the ownership of roads leading to Diyar Al Muharraq and Dilmunia.

The issue carries direct administrative and service implications, particularly regarding maintenance responsibility and infrastructure supervision.

By endorsing the recommendation, the council established clear jurisdictional boundaries, a step viewed as essential for institutional coordination and long-term planning stability.

In Arad, the council approved a technical committee recommendation to convert three properties within Block 242 into a commercial block system.

Bahrain, UAE launch ‘Single Travel Point’ air initiative

Bahrain and the United Arab Emirates have officially launched the “Single Travel Point” air initiative, a landmark project aimed at streamlining air travel between the two countries.

The service was inaugurated yesterday at Bahrain International Airport, marking the commencement of the first phase of this GCC-wide initiative.

The launch follows the decision of the Ministers of Interior of the Gulf Cooperation Council (GCC) States at their 42nd meeting in Kuwait on November 12, 2025, which approved the first phase of the “Single Travel Point” air system.

Implemented in cooperation with the GCC General Secretariat, this initiative represents a major step toward enhancing regional travel integration.

The launch ceremony was attended by the H.E. Deputy Minister of Interior, Lieutenant General Adel bin Khali-

fa Al Fadhel; Major General Suhail Saeed Al Khaili, the Director General of the UAE Federal Authority for Identity, Citizenship, Customs and Port Security, and Jassim Mohammed Al Budaiwi, the GCC Secretary-General.

The Deputy Minister of Interior emphasised that the launch of the first phase of the “Single Travel Point” air project stems from the exemplary relations between the Kingdom of Bahrain and its fellow GCC member states.

He underscored the strategic pathway toward Gulf integration aimed at establishing a smart and integrated mobility system that enhances border security and elevates the passenger experience.

Lt. General Al Fadhel said that the project introduces an advanced operational model enabling travellers to complete their procedures in advance in the country of departure, thereby accelerating transit processes, reducing waiting times, and enhancing the smooth flow of movement.

Aviation ambitions

Tourism and transit development take centre stage in Council session

Tourism and aviation development took centre stage during the Nineteenth Ordinary Session of the Fourth Annual Meeting of the Sixth Legislative Term, as MPs called for accelerated measures to position Bahrain as a stronger regional transit and tourism hub.

MP Mamdouh Abbas Al Saleh highlighted the significance of recent aviation agreements, particularly the deal with AirAsia, describing it as a strategic shift that could expand Bahrain’s connectivity to more than 150 destinations.

He stressed that such agreements must translate into tangible economic benefits and job opportunities for Bahrainis, especially within airport operations and aviation services.

Growth

MP Hesham Ahmed Al Ashiri pointed to official figures indicating that tourism revenues reached BD1.2 billion in 2024, marking substantial growth compared with previous years.

However, he raised concerns about infrastructure bottle-

necks, including congestion on King Fahd Causeway, and questioned whether government entity coordination is keeping pace with rising visitor numbers.

He also called for clarity regarding the suspension of the Bahrain-Qatar travel route and urged better regulation of unlicensed tour guides to protect Bahraini professionals.

Minister of Tourism, Her Ex-

cellency Fatima bint Jaafar Al Sairafi, said the sector forms a key pillar of economic diversification under the national recovery plan.

She noted that Bahrain ranked among the fastest-growing tourism markets in the region in 2025, recording an 11 per cent increase in visitor numbers.

She confirmed that 23 four and five-star hotels have opened

since 2022 and that more than 70 percent of licensed tour guides are Bahraini, with ongoing efforts to strengthen training and regulatory oversight.

MPs emphasised that sustained growth must be matched with improved infrastructure, regulatory clarity and greater participation of Bahraini talent across the sector.

Alba Discloses its Financial Results for the Fourth Quarter and 12 Months of 2025

Q4 & Full-Year 2025 Financial Performance

Aluminium Bahrain B.S.C. (Alba) (Ticker Code: ALBH), the world's largest aluminium smelter on one site, has reported a Profit of BD108.7 million (US\$289.2 million) for Q4 2025, up by 193.4% YoY versus a Profit of BD37.1 million (US\$98.6 million) for the same period in 2024. The Company reported Basic and Diluted Earnings per Share of fils 76 for Q4 2025 versus Basic and Diluted Earnings per Share of fils 26 for the same period in 2024. The Total Comprehensive Income for Q4 2025 stood at BD107 million (US\$284.7 million) versus a Total Comprehensive Income for Q4 2024 at BD38.1 million (US\$101.3 million), up by 181% YoY.

For the Full-Year of 2025, Alba has reported a Profit of BD218.7 million (US\$581.6 million), up by 18.5% YoY, versus a Profit of BD184.5 million (US\$490.8 million) for 2024. Alba reported Basic and Diluted Earnings per Share of fils 154 versus Basic and Diluted Earnings per Share of fils 130 in 2024. Alba's Total Comprehensive Income

for 2025 was BD213.2 million (US\$567 million), up by 16.2% YoY, compared to a Total Comprehensive Income of BD183.4 million (US\$487.8 million) in 2024.

Total Equity as of 31 December 2025 stood at BD2,085.6 million (US\$5,546.8 million), up by 8.4% YoY, versus BD1,923.9 million (US\$5,116.9 million) as of 31 December 2024. Alba's Total Assets as of 31 December 2025 were BD2,623.3 million (US\$6,976.8 million) versus BD2,673.4 million (US\$7,110 million) as of 31 December 2024, down by 1.9%.

The Board of Directors of Aluminium Bahrain B.S.C. (Alba) resolved during the Board meeting on Tuesday 17 February 2026, to recommend the distribution of cash dividend to the shareholders whose names are registered on the Company's register on the Record Date. The final cash dividend is 43.51% of the share nominal value, equivalent to Fils 43.51 per share corresponding to BD61,612,237 (US\$163,862,332).

Aluminium Market Dynamics: Demand & Supply (For more insights, refer to Alba's Investor Relations Presentation)

- Global Economy showed resilience in 2025 while inflation trends stabilised, creating a supportive backdrop for commodities.
- US tariffs significantly lifted domestic aluminium prices, tightened local supply, and pressured downstream margins, while resulting in only limited short-term increases in domestic production.
- Demand remained stable

- (+2% YoY), supported by the packaging, automotive, and electrical sectors. With the exception of from North America (-3% YoY), most regions recorded mild consumption gains.
- On the Supply side, global aluminium output rose by just 2% YoY, constrained by structural capacity limits in China and slower-than-expected recovery in other regions. Canadian production declined by 1% YoY, reflecting tariff-driven export adjustments.
- Market Balance: As

Chinese production is growing at a slower pace than consumption (while remaining capped at 45 million tonnes annually), the global market is showing a surplus of 118kMT including China and 229kMT excluding China.

Aluminium Market Prices, Inventories & Premium

LME Price averaged US\$2,630/t in 2025 (+9% YoY). Prices remained volatile, with Q4 fluctuating between a low of US\$2,683.5/t and a high of US\$2,968/t, supported by solid market fundamentals, fund

inflows, and ongoing supply constraints.

- Regional Premiums remained firm. The US Midwest premium continued its upward trend, driven by reduced imports and ongoing destocking. European premiums increased on the back of stronger end-user confidence and pre-CBAM purchasing activity. In contrast, the MJP premium softened due to localised oversupply pressuring regional sentiment.
- Inventories declined 20% YoY to 509,000 MT. A significant portion of stocks remained of Russian origin, reducing effective availability for Western consumers due to sanctions and trade restrictions.

NBB records 4% growth in net profit

Manama

National Bank of Bahrain B.S.C. (NBB) has reported a 12% increase in its net profit attributable to shareholders reaching BHD 18.2 million (USD 48.3 million) for the fourth quarter ended 31 December 2025, compared to BHD 16.2 million (USD 43.0 million) in the same period of 2024. The profitability performance was primarily attributable to higher net interest income driven by the Group's resilient balance sheet.

Earnings per share increased to 8 fils (USD 2 cents) for the fourth quarter of 2025 compared with 7 fils (2 cents) in the same period of 2024.

Total comprehensive income attributable to NBB's shareholders for the quarter decreased by 15% to BHD 16.7 million (USD 44.3 million) compared to BHD 19.6 million (USD 52.0 million) in the same period of 2024. The decrease is attributable to the negative mark-to-market movements of the bond portfolio.

Year-to-date

NBB has reported a 4% increase in its net profit attributable to the shareholders for the year ended 31 December 2025, reaching a record level of BHD 85.1 million (USD 225.7 million) compared to BHD 81.9

million (USD 217.3 million) for the year 2024. The increase reflects the Group's diversified non-interest revenue streams.

Earnings per share increased to 38 fils (USD 10 cents) for the year compared with 36 fils (10 cents) in 2024.

Total comprehensive income attributable to NBB's shareholders for the year ended 31 December 2025 decreased by 9% to BHD 82.7 million (USD 219.3 million) compared with 91.0 million (USD 241.4 million) in 2024. The decrease is primarily attributable to the negative mark-to-market movements of the equity portfolio.

Balance sheet

The Group's total equity attributable to shareholders increased to 585.0 million (USD 1,551.7 million) as of 31 December 2025 compared to BHD 583.8 million (USD 1,548.5 million) reported as of 31 December 2024.

The Group's total assets increased by 14% during the year to BHD 6,276.6 million (USD 16,648.8 million) compared to BHD 5,522.2 million (USD 14,647.8 million) recorded on 31 December 2024 and was driven by the Group's core activities.

Dividend

Following the Group's strong

performance, the Board of Directors proposed a cash dividend of BHD 79.0 million or 35% per share equivalent to 35 fils, inclusive of 10% interim dividends announced and paid during August 2025.

The appropriations are subject to the approvals of the regulatory authorities and the shareholders at the Annual General Meeting.

Commentary

On the occasion, Mrs. Hala Ali Husain Yateem, Chairperson of NBB, said: "NBB concluded 2025 with record financial results, reporting an attributable net

profit of BHD 85.1 million – a 4% increase over the previous year and the highest annual profit in the Bank's history. These results highlight our financial resilience, which sets us up for long-term growth and sustained value creation. With a return on average equity of 15% and a proposed dividend distribution of 35% for the year, we continue to deliver competitive returns to our shareholders. Beyond our financial achievements, we continued to embed ESG principles further across our operations and financing activities. As we enter 2026, we remain focused on prudent governance and a clear strategic vision to deliver

er measurable impact for our shareholders, customers, and the Kingdom of Bahrain."

Usman Ahmed, Group Chief Executive Officer of NBB, commented: "We ended the year with an operating profit of BHD 93.4 million, marking a 3% rise over 2024. Our strong profitability was further supported by continued growth of our balance sheet, with total assets increasing by 14% relative to year-end levels. Loans and advances and customer deposits grew by 6%, reflecting sustained momentum across the Group's core banking activities. We continued to deepen our commitment to customer excellence, opening 6 SME across Bahrain, launching digital loan top-ups for our retail customers, introducing host-to-host connectivity for our corporate clients and introducing an AI assisted Chatbot for augmenting service. Our KSA and UAE businesses posted combined loan growth of 52% as we strengthened our presence across diversified customer segments, industries, and solutions. Our employees contributed over 1,000 volunteering hours towards several educational and entrepreneurial programmes. We are committed to building upon our operational strengths and delivering excellence across every dimension of our business."

The Board of Directors of National Bank of Bahrain B.S.C. resolved, at its meeting held on 17 February 2026, to recommend the distribution of dividends for the year ending 31 December 2025 to the shareholders whose names are registered on the Bank's register on the Record Date. This is subject to the approval of the regulatory authorities and the Bank's shareholders at the upcoming Annual General Meeting. The proposed distribution is as follow:

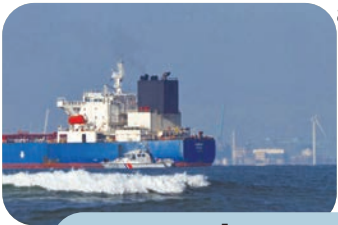

News in brief

◆ **France yesterday** released tanker called Grinch suspected of being part of Russia's sanctions-busting "shadow fleet" after its owner paid a fine of several million euros, a minister said. French forces and their allies boarded the oil tanker last month between Spain and Morocco after it started its journey in Russia. It was escorted to a port near the southern city of Marseille. Ship tracking websites MarineTraffic and VesselFinder said the vessel had been flying a Comoros flag. The ship is suspected of being part of a shadow fleet that carries oil for countries such as Russia and Iran in violation of US sanctions. "The tanker Grinch is leaving French waters after paying several million euros and enduring a costly three-week immobilisation in Fos-sur-Mer," Foreign Minister Jean-Noel Barrot said on X.

◆ **Iran will close** parts of the strategic Strait of Hormuz for "safety" measures during military drills by its Revolutionary Guards, state TV reported yesterday. Parts of the Strait of Hormuz will be closed in order to respect the principles of safety and navigation," said a state TV journalist, reporting from a site near the drills, which began on Monday. He said the partial closure would last for "a few hours". On Monday, the Islamic Revolutionary Guard Corps began a series of military exercises to prepare against "potential security and military threats" in the strait. The duration of the war games was not specified. The drills took place after the United States deployed a large naval force to the Gulf in an attempt to pressure Iran to reach an agreement over its nuclear programme.

◆ **India's IT minister** apologised yesterday to visitors to a global artificial intelligence summit who had complained of overcrowding and other organisational problems on the first day. The AI Impact Summit in New Delhi, the fourth in a series of annual gatherings to discuss the fast-evolving technology, is the largest edition yet and also the first held in a developing country. Organisers are expecting tens of thousands of attendees, from top-level national delegations to companies, campaigners and students. But not all areas of the vast conference site were open when big crowds showed up to the five-day event that opened on Monday, with some visitors saying the entry systems and other provisions were not up to scratch. "If anybody has faced any problems yesterday, my apologies for that. We are working very hard," IT minister Ashwini Vaishnaw said at a news conference on Tuesday. "We definitely will make efforts to make it more smooth and make it more enjoyable for all of you," he said. "This is the biggest AI summit in the entire world. The response is phenomenal, the energy is palpable," Vaishnaw added, inviting feedback on the operations.

17th century wreck reappears from Stockholm deep

A 17th century Swedish Navy shipwreck buried underwater in central Stockholm for 400 years has suddenly become visible due to unusually low Baltic Sea levels. The wooden planks of the ship's well-preserved hull have since early February been peeking out above the surface of the water off the island of Kastellholmen, providing a clear picture of its skeleton. "We have a shipwreck here, which was sunk on purpose by the Swedish Navy," Jim Hansson, a marine archeologist at Stockholm's Vrak - Museum of Wrecks, told AFP. Hansson said experts believe that after serving in the navy, the ship was sunk around 1640 to use as a foun-

ation for a new bridge to the island of Kastellholmen. Archeologists have yet to identify the exact ship, as it is one of five similar wrecks lined up in the same area to form the bridge, all dating from the late 16th and early 17th centuries. "This is a solution, instead of using new wood you can use the hull itself, which is oak" to build the bridge, Hansson said. "We don't have shipworm here in the Baltic that eats the wood, so it lasts, as you see, for 400 years," he said, standing in front of the wreck. Parts of the ship had already broken the surface in 2013, but never before has it been as visible as it is now, as the waters of the Baltic Sea reach their lowest level in about 100 years, according to the archaeologist.

UAE extends Mars probe mission until 2028

The United Arab Emirates announced yesterday that it would extend its Mars probe mission, now in its fifth year, for an additional three, underlining the oil-rich state's space ambitions. The UAE's Hope probe arrived in orbit around Mars in 2021 after a seven-month voyage through space, making it the first Arab country to explore the Red Planet with a \$200 million investment. The Emirates Mars Mission (EMM) initially planned to collect one terabit of data on the Martian atmosphere. It ultimately collected 10 terabits and will be extended until 2028, Ahmad Belhoul Al Falasi, UAE Minister of Sports and Chairman of the Board of Directors of the UAE Space Agency, said during a press conference in Dubai.

Iran FM says agreed with US 'on guiding principles' for deal

Iran's Foreign Minister Abbas Araghchi said yesterday the latest talks with the United States saw them agree on "a set of guiding principles" that would pave the way for a deal. "Ultimately, we were able to reach broad agreement on a set of guiding principles, based on which we will move forward and begin working on the text of a potential agreement," Araghchi told state TV. "I can say that, compared with

the previous round, fully serious discussions were raised and the atmosphere was more constructive," he added. Tehran and Washington held on Tuesday a second round of negotiations -- which began earlier this month -- after talks last year collapsed following Israel's attack on Iran in June, which triggered a 12-day war. That war saw the United States briefly join Israel with strikes on key Iranian nuclear sites. The latest talks were held after

Washington deployed an aircraft carrier group to the Middle East following Iran's deadly crackdown last month on anti-government protests, first sparked by economic hardships. During the interview with state TV, Araghchi said the two sides have begun a path towards an agreement, but noted that "this does not mean we can reach a deal quickly". "We hope this process can be completed as soon as possible and we are ready to devote sufficient time to it," he added.

Al-Aqsa imam says Israel barring him from entering mosque ahead of Ramadan

● The month of Ramadan is expected to begin this week.

AFP | Jerusalem, Undefined

A senior imam of the Al-Aqsa Mosque in east Jerusalem said yesterday that Israeli authorities have barred him from entering the compound, just days before the start of the Muslim holy month of Ramadan.

"I have been barred from the mosque for a week, and the order can be renewed," Sheikh Muhammad al-Abbasi told AFP.

He said he was not informed of the reason for the ban, which came into effect from Monday.

"I had only returned to Al-Aqsa a month ago after spending a year in the hospital following a serious car accident," Abbasi said.

"This ban is a grave matter for us, as our soul is tied to Al-Aqsa. Al-Aqsa is our life."

The month of Ramadan is expected to begin this week.

During the holy month, hundreds of thousands of Palestinians traditionally attend prayers

at Al-Aqsa -- Islam's third-holiest site, located in east Jerusalem, which Israel captured in 1967 and later annexed.

On Monday, Israeli police said they had recommended issuing 10,000 permits for Palestinians from the occupied West Bank,

who require special permission to enter Jerusalem.

Police did not specify whether age restrictions would apply.

The Palestinian Jerusalem Governorate however said it had been informed that permits would again be limited to men over 55 and women over 50, mirroring last year's criteria.

It added that Israeli authorities had prevented the Islamic Waqf -- the Jordanian-run body that administers the site -- from carrying out routine preparations, including installing shade structures and setting up temporary medical clinics.

A Waqf source said 33 of its employees had been barred from entering the compound in the week leading up to Ramadan.

Under long-standing arrangements, Jews may visit the Al-Aqsa compound -- which they revere as the site of the first and second Jewish temples -- but they are not permitted to pray there. Israel says it is committed to upholding this status quo, though Palestinians fear it is being eroded.

India govt discussing age restrictions with social media platforms

India is discussing age-based restrictions with social media companies, following Australia's move to ban under-16s from popular platforms, IT minister Ashwini Vaishnaw said yesterday.

"This is something which has now been accepted by many countries that age-based regulation has to be there," Vaishnaw told reporters at the AI Impact Summit.

"Right now we are in a conversation regarding deepfakes, regarding age-based restrictions with the various social media platforms and... what is the right way to go about this," he said.

Australia in December enforced a ban that required TikTok, YouTube, Snapchat and a host of other top social media services to remove accounts held by young teens, or face heavy fines.

Vaishnaw also signalled tougher oversight of manipu-

lated content online.

"We need much stronger regulation on deepfakes," he said.

"I think it's a problem which is growing day by day. And certainly there is a need for protecting our children, protecting our society from these harms."

India already last week tightened rules regulating artificial intelligence, requiring social media platforms to clearly label AI content and comply with takedown requests by authorities within three hours.

Russia military police building collapses near Saint Petersburg, causes unclear: governor

A Russian military police building collapsed on the grounds of an army base outside Saint Petersburg, the local governor said yesterday, adding that authorities were probing the causes of the incident.

"I have instructed the security forces to assist the military in clearing the rubble and rescuing victims following the collapse of a military police building on the territory of a military unit in Sertolovo," governor Alexander Drozdenko said.

"The causes of the incident are being investigated," he added.

Sertolovo is a small village just outside Saint Petersburg, Russia's second-biggest city.

Local media outlet 47news reported that three people died in the incident, citing emergency services.

It reported that the collapse was caused by an "explosion".

The outlet also published an

unverified photo purporting to show the building, a grey three-storey block with damage visible on at least two floors.

Russia has been regularly hit with sabotage attacks on military bases and civilian infrastructure since the start of its

Ukraine offensive nearly four years ago.

Gas leaks are a frequent cause for explosions in Soviet-era buildings in Russia, although authorities gave no immediate indication this was the cause.

Greece experts to examine Nazi atrocity photos find

Greece's culture ministry said Monday that a trove of photographs that appear to capture one of Nazi Germany's worst atrocities in the country appear to be authentic.

The ministry said it was sending experts to Ghent, Belgium to examine the photos and to talk to a collector of Third Reich memorabilia who had put them on sale on Ebay on Saturday.

"It is highly likely that these are authentic photographs," the



One documented Nazi atrocity in Greece occurred in the village of Distomo on 10 June 1944. Units of the Waffen-SS massacred 218 civilians, including women and children, in retaliation for partisan activity in the area. Victims were shot, stabbed, and killed inside their homes.

ministry said.

It said the 12 photographs appear to show "the last moments" of 200 Greek Communists who were executed on May 1, 1944

in retaliation for the killing of a German general and his staff by Communist guerrillas a few days earlier.

The Communist-led Greek

People's Liberation Army (ELAS) was among the most active resistance organisations in occupied Europe.

The execution of the 200 men at the Kaisariani shooting range in Athens is a seminal event of the 1941-1944 Nazi occupation of Greece, which was marked by several atrocities, mostly against Greek villagers.

Greece's Jewish community was also decimated during this period.

Some of the pictures show

groups of the men marching through a field, and standing against a wall at the shooting range.

One photo appears to show the men being marched into the shooting range, after discarding their overcoats outside.

"This is the first time we have an image from inside the shooting range at the moment of the execution...a major moment of the Greek resistance movement," historian Menelaos Haralambidis told state TV ERT.

Al Tamimi Delivers Standout Run at Barcelona Half Marathon

Bahrain's Ibrahim Al Tamimi produced a strong performance at the 37th Barcelona Half Marathon, finishing 43rd overall among a record 36,000 runners from 93 countries.

Al Tamimi clocked 1:03:25 over the 21.1km distance, maintaining an impressive average pace of 3:00 minutes per kilometre. His result marked the fastest time recorded by a Bahraini athlete in the history of the race.

The event was one of the most competitive editions to date, highlighted by Ethiopia's Hagos Gebrhiwet winning in a



world-leading 58:05 and Kenya's Loice Chemnang setting a women's course record of 1:04:01. Against that elite international field, Al Tamimi delivered a controlled and disciplined race to secure his top-50 finish.

Despite challenging wind conditions in Barcelona, he maintained consistency throughout, demonstrating both race management and endurance at a high level. The performance reinforces his position among the Kingdom's leading road runners and adds another notable international result to his record.

Australia, Ireland out of T20 World Cup as Zimbabwe qualify after washout

The 2021 champions Australia were knocked out of the T20 World Cup yesterday, with Zimbabwe qualifying for the Super Eights after their match against Ireland was washed out without a ball being bowled in Kandy.

Zimbabwe joined Sri Lanka as qualifiers from Group B and will move on to face the West Indies, India and South Africa in the next phase. Ireland were also eliminated.

Persistent drizzle all day at the Pallekelle stadium kept the covers on and the umpires finally called it off at 5:30 pm local time (1200 GMT) with no prospect of beginning the minimum five-over match before the 6:10 pm cut-off time.

Australia, who had been beaten by Sri Lanka and Zimbabwe, needed an Ireland victory to keep their hopes alive.

Zimbabwe are now on an unassailable five points with a game to still to come, while Ireland are third on three points.

Australia, on two points, have one game remaining against Oman on Friday, but cannot overtake Zimbabwe.

Australia had a shambolic build-up to the tournament

They lost leading pace bowlers Pat Cummins and Josh Hazlewood to injury, while captain Mitchell Marsh missed the first two games after being hit in the groin in training and suffering

testicular bleeding

Test great Steve Smith was left out despite being in terrific form top of the order in the Big Bash League and his expertise in playing against spin bowling.

He flew in as cover last week and was formally added to the Australia squad at the weekend.

But then he was left out for the must-win game against

Sri Lanka on Monday which saw an Australia middle-order collapse as they lost by eight wickets.

Zimbabwe captain Skiander Raza hailed his side's achievement in reaching the last eight, but warned there were tougher battles to come.

"We have come this far. We will celebrate but we have a game against Sri Lanka to come," said Raza.

"This is only a tick in the box and this is not the only thing that we set out for. Everyone loves an underdog story."

Ireland skipper Lorcan Tucker was downcast after his side did not get to play.

"Obviously very disappointed to go out in this fashion, but completely uncontrollable," said Tucker.

"Our batting failed. There were big moments in the tournament particularly against Sri Lanka when we dropped so many catches.

"Hopefully, we will handle these tough situations differently moving forward."

No pressure on India opener Abhishek after two ducks, says coach

India opener Ashishek Sharma should not feel under pressure at the T20 World Cup after failing to score a run so far, because he has "a clear plan and clear mindset", a team coach said yesterday.

Defending champions India have won three from three in Group A.

They face the Netherlands in Ahmedabad on Wednesday in their final group match with their berth in the Super Eights already assured.

But the form of the usually explosive left-hander Abhishek has been under scrutiny.

"We don't unnecessary over-analyse," India batting coach Sitanshu Kotak told reporters.

"Because sometimes you start to make your own assumptions what the opposition are doing.

"He has his plans sorted and follows the way he wants to play.

"Obviously we discuss about the oppositions and their

bowling strengths. It is all normal for every batter."

The 25 year-old missed the second match against Namibia with a stomach infection.

Either side of that he registered two ducks -- out first ball in the opener against the USA and fourth ball against Pakistan -- meaning he has only faced five balls all tournament.

"He has made runs before he was unwell," said Kotak.

"The T20 format is a high-risk game and players will get out at some point. If we start stressing on such things then there will be pressure on players.

"He is in good form, he has got a clear plan and clear mindset."

Kotak said there were no dead rubbers for India, ahead of the match against the Dutch that will now have no bearing on the tournament.

"Every game is important for momentum," he said.

"We played the last game with the same intent and will play the next game with the same intent."

Tariq confident Pakistan can bounce back after India drubbing

Spinner Usman Tariq said yesterday he was confident that Pakistan can bounce back from their T20 World Cup drubbing against India and seal qualification for the next round.

India's 61-run romp means Pakistan must beat Namibia in their final match in Colombo on Wednesday to qualify for the Super Eights.

A defeat would eliminate Pakistan, who are third behind the USA on net run rate in Group A.

It would also leave an outside chance for the Netherlands to qualify, but they would need a big win over co-hosts India in Ahmedabad on Wednesday.

"Lifting the team is only difficult when you don't work on your mistakes committed

in the last game," Tariq told reporters.

"We have worked on our mistakes so I think it will not be a tough task.

"We have a resolve not to commit the same mistakes again."

Pakistan were criticised for asking India to bat then folding meekly for 114 in 18 overs chasing a stiff 176 target.

"We can feel their (fans') disappointment because the match is watched by the whole nation," Tariq said.

"So we feel their pain but I am sure when we play them (India) next we will put up a better show."

Tariq dismissed rumours that batting star Babar Azam and pace spearhead Shaheen Shah Afridi could be dropped against Namibia after poor performances against India.

Gauff will face Belgian Elise Mertens in the last 16.

The two-time Grand Slam champion created headlines earlier this week for comments about anti-immigration policies in the United States, saying: "I don't think people should be dying in the streets for just existing."

Gauff struggled at times in Dubai, serving 12 double-faults, but broke Russian Kalinskaya's serve six times to emerge victorious from a scrappy encounter.

"It wasn't the prettiest one,

but it was enough for today," Gauff, seeded third, said.

"It was pretty windy. I was just trying to adjust -- both of us were struggling with consistency on the court."

Mirra Andreeva and Belinda Bencic were both beneficiaries of second-round walkovers.

Russian teenager Andreeva, who received a first-round bye, will face Romanian Jaqueline Cristian for a quarter-final place after Daria Kasatkina pulled out with a hip injury.

In-form Czech youngster Sara Bejlek, who won a title in Abu Dhabi earlier this month, also withdrew with an abdominal injury, handing Bencic a spot in round three.

American fourth seed Jessica Pegula cruised through with a 6-4, 6-0 thrashing of Varvara Gracheva and will next play compatriot Iva Jovic.

The tournament in Dubai, one of the 10 WTA 1000 competitions, has been severely hit by the withdrawals of world number one Aryna Sabalenka and six-time Grand Slam

Evenepoel takes UAE Tour lead with time-trial win

Belgian star Remco Evenepoel continued his excellent start to the season with victory in a second-stage time trial to take the overall lead of the UAE Tour yesterday.

New Zealand cruise into Super Eights at T20 World Cup

New Zealand sealed their qualification to the next phase of the T20 World Cup with an eight-wicket thumping of Canada in Chennai yesterday.

Chasing 174 to win, New Zealand were never in trouble and reached 176-2 with almost five overs to spare.

Glenn Phillips was on 76 not out at the end with Rachin Ravindra unbeaten on 59.

"We did get on a bit of a run at the end there, which was fantastic," said Phillips.

"But honestly, Rach and I were just trying to stick to our processes and take it one ball at a time."

The result eliminates the 2024 semi-finalists Afghanistan as New Zealand joined South Africa as the two qualifiers for the Super Eights from Group D.

Canada's Yuvraj Samra earlier became the youngest player to score a T20 World Cup century, when he blasted 110 in 65 balls

to help his side to 173-4.

The 19-year-old brilliantly anchored the innings after captain Dilpreet Bajwa opted to bat first.

Samra and Bajwa got Canada off to a superb start with an opening partnership of 116 in

14 overs.

Bajwa fell caught by Phillips off Kyle Jamieson for 36, but Samra carried on and accelerated after the loss of his captain.

He reached his hundred off 58 balls, hitting six sixes and 11

"To do it here, in my first appearance, and as the youngest player in this World Cup, it's truly a dream come true."

Phillips was full of praise for the teenager, calling his innings "fabulous".

"He's a really clean striker of the ball. Got a long future ahead of him."
