Bahrain pauses at sunset for first iftar of season



As the sun dipped below the horizon yesterday evening, the Maghrib call to prayer rang out across Bahrain, moments after the traditional cannon fire echoed through the skies.

It signalled the time to break the fast, marking the first iftar of the season.

Wherever people were, at home, at work, on the street, or even traveling, everyone paused, stopping for a moment to share dates and water and reflect in unison.

The city seemed to hold

its breath, united in a quiet, spiritual pause before the evening meals began.

This year, Muslims across the Kingdom will fast for

a total of 398 hours and 35 minutes throughout Ramadan.

On average, that amounts to roughly 13 hours of fasting per

day, closely aligned with the GCC average of about 13.5 hours daily.

Fasting durations will gradually lengthen as the month progresses, increasing by ap-

proximately one minute and 25 seconds each day due to seasonal daylight changes.

Transition

While the difference may seem small, it reflects the steady transition toward longer days.

Beyond the figures, Ramadan represents a time of spiritual renewal, discipline and compassion.

The first iftar not only marked the end of the day's fast, but also the beginning of 398 hours devoted to prayer, patience and strengthening bonds within families and communities across Bahrain.

One careless act at sea could cost life

“There is no doubt that the sea is a blessing, and its heritage is a source of goodness — a symbol of Bahrain,” said Colonel Dr. Osama Bahar, Head of Hidd Police Station.

He reminded fishermen and sea-goers that while the sea provides both livelihood and enjoyment, safety should never be overlooked.

Colonel Bahar urged the public to take precautions: stay away from industrial facilities and never approach restricted areas, particularly military zones.

Responsibility

He also stressed environmental responsibility: “When fishing in permitted areas, do not leave waste behind, particularly plastic. It is harmful to fish and other marine life.”

For personal safety, he offered practical advice: “Do not fish from bridges. Many incidents have occurred when someone was fishing from above while boats passed underneath.”

Nighttime fishing also requires caution, he added: “Do not assume it is safe at night. Boats or jet skis may pass below, and one careless act could seriously injure someone.”

He concluded with emergency guidance: “If you need assistance, call 999 or 994. Do not hesitate, we care about your safety.”

From pitch to prayer

Old football ground in Al Zallaq set for transformation as Eid worshippers' venue

A former football pitch in Al Zallaq is set to be transformed into a dedicated Eid prayer ground after the Southern Municipal Council unanimously approved its reallocation.

The decision marks a significant shift in the use of public land, reflecting changing community priorities within Block 1056.

The ground, once used for local matches and informal training sessions, has seen limited sporting activity in recent years.

Expansion

Meanwhile, the surrounding neighbourhood has continued to expand, increasing the demand for a permanent and well organised space capable of hosting large congregations during Eid prayers.

Members agreed that relying on temporary arrangements was no longer practical for a district experiencing steady population growth.

Families attending Eid prayers require broader, safer open areas that can comfortably accommodate worshippers while ensuring smooth access and movement.

By converting the old football field into a prayer ground, the council aims to provide a structured venue designed specifically for major religious oc-

casions, improving organisation, safety, and the overall resident experience.

Agreement


The unanimous vote underscores broad agreement that public facilities must evolve in line with demographic realities.

Rather than allowing the former pitch to remain underuti-

lised, councillors endorsed its reassignment to serve a more immediate and widely felt community need.

The move illustrates a pragmatic municipal approach, where land once dedicated to sport now finds renewed purpose at the heart of the district's social and religious life.

Zallaq street set for upgrade

The comprehensive redevelopment of Street 96 in Zallaq has been approved without objection, paving the way for long awaited improvements to one of the area's key roads in the Eighth District of the Southern Governorate.

The project responds to long standing concerns over road deterioration, traffic pressure, and the overall condition of surrounding infrastructure.

Street 96 serves as an important internal route within Zallaq, linking residential areas and handling steady daily vehicle movement, particularly during weekends and peak hours.

Plans include full resurfac-

ing works, upgrades to the carriageway, and measures aimed at improving traffic flow and road safety.

The redevelopment is also expected to review lane organisation to align with increasing usage and the area's continued growth.

Members agreed that maintaining strategic roads is essential to preserving quality of life and supporting broader urban development. By moving forward with a structured upgrade, the council aims to restore functionality and elevate infrastructure standards in Zallaq.

Councillors emphasised that modern road improvements are fundamental to public safety. Well maintained streets reduce accident risks.

MP seeks return of funding for 13 senior day-care centres

Funding for 13 day-care centres caring for parents and senior citizens should return after it was stopped years ago, an MP has said.

Mohammed Al Olaiwi has filed a proposal asking the government to instruct the Ministry of Social Development to bring

back annual financial support for the centres, which include homes, associations and institutions.

“This would help guarantee the continued work of these centres,” he said, arguing that the money would help them keep services running and widen what they offer.

Al Olaiwi said the centres provide day care and social support,

alongside family and health services for members.

Projects

He linked their work to the Community Partnership Project, which aims to bring government, civil society groups and the private sector together through care programmes and initiatives that are turned into longer-term projects.

He said the centres aim to keep older people involved in community life by running activities, programmes and workshops, and by helping them keep in touch with others.

“They provide a suitable environment that takes account of older people's privacy,” he said, adding that they help avoid “isolating them in residential shelters”.

Repair rethink

Muharraq Souq upgrade plan sent back to committee after ‘cosmetic’ fix row

A dispute over “cosmetic” fixes at Muharraq Souq led councillors to return an upgrade plan to committee for reconsideration, with members saying the site’s long-running problems need deeper work before any recommendation goes back to the council floor.

The recommendation was submitted by council chairman Abdulaziz Al Naar and focused on listing the market’s key needs.

It included proposals for enough, well-run car parking, dedicated spaces for loading and unloading, facilities suited to people with disabilities, suitable public toilets, points selling water and tea, and suitable spaces for women’s prayer.

Response

Member Fadhil Al Oud said the issues were plain to see, but said the response so far had not dealt with the main cause.

“The problem in Muharraq Central Market is clear to everyone, but dealing with it has been cosmetic,” he told the session. “Just providing parking or par-

tial fixes is like “make-up” for the problem, without solving it from the roots.”

He said the core issue was the removal of agricultural basins and replacing them with car parks, adding that the work carried out in relation to those basins was unsound and needed correction.

Updates

Member Abdulqader Mahmood said there had been a number of new updates in the file, noting that Al Naar was aware of them after a meeting with several parties to discuss

the latest developments.

He said the new information shaped the wording of the recommendation and called for it to be returned to the relevant committee so it could be reviewed again and presented

more clearly to the council.

The council voted to refer the recommendation back to the committee, ahead of bringing it again to the council once the review is complete and the latest developments are presented.

Appeal verdict set in hot water assault case

The First High Criminal Court of Appeal has set March 16 to issue its ruling in the appeal of a man in his twenties convicted of assaulting a female co-worker by throwing hot water on her, causing a permanent disability assessed at 5 percent.

He was previously sentenced to three years in prison by the High Criminal Court.

The incident stemmed from a workplace dispute at a café over handling an order.

The argument escalated when the defendant assaulted the victim, knocking her to the ground before staff intervened.

Shortly afterward, he called her name, and when she turned toward him, he threw hot water at her face from a container used to prepare drinks.

Assistance

According to the victim’s report, she had asked the de-

fendant for assistance earlier that morning but received no response.

She then logged into the cashier system and closed his account, which angered him and led to the assault.

After colleagues separated them, she believed the situation had ended and called the manager.

At that moment, the defendant called her again and threw hot water at her face.

Staff escorted her outside, but the defendant followed and struck her on the head with a metal water heater.

During questioning, the defendant admitted to the assault.

Prosecutors charged him with intentionally causing a permanent injury and physically assaulting the victim.

Forensic medical reports confirmed that the victim sustained burns and injuries resulting in a permanent disability estimated at 5 percent.

Man detained for vandalising vehicles

That dedication, he said, has turned farms into an essential pillar supporting national food security.

In recent years, he added, support for farmers has become more structured, with efforts focused on securing suitable agricultural land and providing natural fertilisers to improve productivity through sustainable methods.

Dr. Al Wedai praised the cre-

ativity and initiative shown by local farmers, saying the global recognition received during the FAO conference in Rome should serve as motivation to continue innovating.

With continued backing from the Ministry of Municipalities Affairs and Agriculture, he expressed confidence that Bahrain’s agricultural sector will see further growth, helping strengthen food reserves and advance the national development vision.

Retired medical equipment to support educational institutions

A proposal to redirect retired medical equipment from public hospitals to educational institutions received unanimous approval from the Southern Municipal Council, marking a step towards greater sustainability and support for medical training.

The initiative centres on utilising devices withdrawn from clinical service but remain suitable for instructional purposes.

Instead of being auctioned or disposed of, this equipment would go to colleges of medicine and health sciences, where students can gain practical exposure during foundational and applied training stages.

Solution

Members agreed that the move represents a practical solution balancing financial responsibility with educational benefit.

By repurposing assets the state already owns, institutions can reduce the cost of acquiring brand new training devices, while simultaneously limiting waste.

The approach also aligns with broader principles of rationalising public expenditure and ensuring that government assets continue to generate value even after their primary

operational lifespan ends.

Competence
Councillors highlighted that early hands on familiarity with real medical equipment strengthens students’ technical competence before they enter the workforce.

The proposal is therefore expected to enhance graduate readiness, improve training quality, and reinforce cooperation between the health and education sectors.

The unanimous vote reflects consensus that public resources should be managed strategically, with long term benefit in mind.

By transforming retired equipment into educational tools, the council endorsed a model that merges sustainability, fiscal prudence, and national capacity building within the healthcare field.

Social insurance for self-employed workers

A proposal to bring free-lancers and other self-employed workers under mandatory social insurance won unanimous approval in Parliament.

The measure amends Article (2) of the Social Insurance Law issued by Decree-Law No. 24 of 1976, widening compul-

sory cover beyond workers on employment contracts to include self-employed people and members of the liberal professions. The added cover will apply only to groups named in a decision by the competent minister, and only after the Social Insurance Organisation’s board signs off, under the wording backed by MPs.

Five MPs submitted the pro-

posal: Maryam Al Sayegh, Najeeb Al Kowari, Hassan Ibrahim, Jameel Mulla Hassan, and Mohammed Mousa. The Services Committee had urged approval.

Al Sayegh said the change was aimed at “a valued group of the people of this country”, naming “small-project owners, artisans, fishermen and driving instructors”.

Upgrade for two mosques in Riffa

Reports Net Profit of Over BD 4.75 Million

● Insurance revenue increased by 10%

Bahrain Kuwait Insurance Company (BKIC) B.S.C. (trading code in Bahrain Bourse “BKIC” and in Boursa Kuwait “BKIKWT”) announced its consolidated financial results for the year ended 31 December 2025.

The financial results for the three months ended 31st December 2025

The consolidated financial results for the fourth quarter of 2025 reported a net profit attributable to shareholders of BD 0.922 million compared to BD 1.167 million for the same period last year, representing a decrease of 21%. It is worth noting that this is the first year of implementing the Domestic Minimum Top-up Tax (DMTT), which has impacted profitability.

Earnings per share for the three-month period were 6 fils compared to 8 fils for the same period last year. Total comprehensive income attributable to shareholders reached BD 1.046 million in the fourth quarter of 2025 compared to BD 0.418 million in the fourth quarter of 2024, representing an increase of 150%.

Insurance revenue increased by 10%, rising from BD 28.276 million in the fourth quarter of last year to BD 31.207 million in the fourth quarter of the current year. Insurance service results increased significantly by 142%, from BD 0.285 million in the fourth quarter of last year to BD 0.689 million in the fourth quarter of the current year. Total investment income decreased by 27%, from BD 1.429 million in the fourth quarter of last year to BD 1.037 million in the fourth quarter of the current year, mainly due to a one-off gain related to the sale of property recorded in the previous year.

The financial results for the year ended 31st December 2025

The consolidated financial results for the year ended 31 December 2025 reported a net profit attributable to shareholders of BD 4.753 million, compared to BD 5.169 million for the same period last year, representing a decrease of 8%, mainly due to the first-time implementation of the new 15% Domestic Minimum Top-up Tax. Excluding the impact of this tax, profit attributable to shareholders before tax increased by 1% compared to the same period last year. Earnings per share stood at 32 fils for the current period, compared to 35 fils last year. Total comprehensive income attributable to shareholders amounted to BD 5.527 million, compared to BD 4.838 million for the same period last year, representing an increase of 14%.

The Company achieved a 3% growth in insurance revenue, reaching BD 117.309 million compared to BD 114.183 million in the previous year. Insurance service results increased by 18%, reaching BD 3.422 million compared to BD 2.893 million in the previous year. Net investment income increased by 13%, from BD 4.844 million in the previous year to BD 5.473 million in the current year.

Total shareholders' equity as at the end of December 2025 stood at BD 46.471 million, compared to BD 44.901 million at the end of the previous year, representing an increase of 3%. Total assets as at the end of December 2025 reached BD

246.573 million, compared to BD 186.017 million at the end of the previous year, representing an increase of 33% due to increase in claims which are reinsured. Net insurance contract liabilities increased from BD 64.433 million at the end of the previous year to BD 70.297 million at the end of the current year, representing an increase of 9%.

Board of Directors' Comments:

US tech giants announce India deals at AI summit

Google said it would build new subsea cables from India and chip titan Nvidia unveiled tie-ups with computing firms yesterday as tech giants rushed to announce deals and investments at a global AI conference in New Delhi.

This week's AI Impact Summit is the fourth annual gathering to discuss how to govern the



fast-evolving technology -- and also an opportunity for India to raise its profile in the booming

sector.

“India's going to have an extraordinary trajectory with AI and we want to be a partner,” Google CEO Sundar Pichai told reporters as the US firm unveiled a plan to boost connectivity to the South Asian country.

New direct undersea connections from India to Singapore, South Africa and Australia will be constructed, it said, touting

faster connections as demand for computing power, including AI, ramps up.

It is part of Google's \$15 billion investment announced in October to construct its largest AI data centre hub outside the United States, in Visakhapatnam, a port city in the southeastern state of Andhra Pradesh.

Also on Wednesday, the California-based Nvidia -- the

world's most valuable company -- said it was teaming up with three Indian cloud computing providers to provide advanced processors for data centres that can train and run AI systems.

Dozens of world leaders and ministerial delegations are in New Delhi for the summit to discuss the opportunities and threats, from job losses to misinformation, that AI poses.

Last year India leapt to third place -- overtaking South Korea and Japan -- in an annual global ranking of AI competitiveness calculated by Stanford University researchers.

But despite its plans for large-scale infrastructure and grand ambitions for innovation, experts say the country has a long way to go before it can rival the United States and China.

ECB says ‘no decision’ by Lagarde on reported early exit

The European Central Bank said Wednesday its President Christine Lagarde had taken no decision on leaving before her term expires, following a media report.

The Financial Times, citing a source familiar with Lagarde’s thinking, said Lagarde would step down before her term ends in October 2027.

In doing so, she would give German Chancellor Friedrich Merz and French President Emmanuel Macron time to determine a successor ahead of France’s presidential vote in April 2027.

“President Lagarde is totally focused on her mission and has not taken any decision regarding the end of her term,” an ECB spokesperson said.

Lagarde, a French politician and lawyer, was named ECB

chief in November 2019 after an eight-year stint as head of the International Monetary Fund. She has won praise from many economists as an unflappable crisis manager, from the global financial sector meltdown in 2008 to the Greek and Argentine debt crises.



Christine Lagarde was once a member of France’s national synchronized swimming team as a teenager – before going on to become the first woman to lead major global financial institutions like the International Monetary Fund and the European Central Bank.

News in brief

◆ **Thirty-eight lead** miners were killed when gas exploded at a pit in central Nigeria's Plateau state, local sources told AFP. Twenty-seven others were injured in the blast at the Kampanin Zurak mining site in Plateau state's Bashar district, the acting traditional ruler told AFP. "So far 38 people are confirmed dead and about 27 others have been rushed to hospital," said the leader, Alhaji Aliyu Adamu Idris. Ibrahim Dattijo Sani, a miner at a nearby pit, told AFP that the victims were below ground in the mine where the explosion struck between 7:30 and 8:00 am (0630 and 0700 GMT). "We are close to the sites, people were inside the mining pits and suddenly a gas exploded," Sani said. "We tried many efforts for rescue but unfortunately 38 people have died... others have been taken to hospital." A confidential security report seen by AFP attributed the death of the miners to "carbon monoxide poisoning".

Germany's Merz open to social media ban for minors



◆ **German Chancellor** Friedrich Merz is open to a social media ban for minors, he said yesterday, following moves by Australia and other countries to keep young teens off popular platforms. Merz said he is usually sceptical about prohibitions, but added that "I think the main focus must be on how to protect children at an age when they also need time to play, learn and concentrate at school". Speaking on the podcast Machtwechsel, he said his government is considering "various ways of handling it in a more restrictive manner", including an age limit and forcing platforms to verify users' ages. Several nations are toughening up age restrictions on social media platforms as concerns mount that excessive screen time could harm childhood development and mental health.

◆ **Iran and Russia** will conduct naval manoeuvres in the Sea of Oman on Thursday, following the latest round of talks between Tehran and Washington in Geneva, Iranian media reported. On Monday, the Revolutionary Guards, the ideological arm of Iran's military, also launched exercises in the strategic Strait of Hormuz, a challenge to US naval forces deployed in the region. "The joint naval exercise of the Islamic Republic of Iran and Russia will take place tomorrow (Thursday) in the Sea of Oman and in the northern Indian Ocean," the ISNA agency reported, citing drill spokesman, Rear Admiral Hassan Maghsoudloo. "The aim is to strengthen maritime security and to deepen relations between the navies of the two countries," he said, without specifying the duration of the drill.

Spanish police arrest hacker who booked luxury hotels for one cent

Spanish police said Wednesday they had arrested a 20-year-old man who allegedly hacked a hotel booking website to reserve luxury rooms for as little as one cent, in the first known cybercrime of its kind.

The suspect is believed to have manipulated the site's payment system, altering the validation process of an electronic payment platform so that bookings appeared fully paid.

But only a minimal amount -- one cent -- was actually charged for rooms costing up to 1,000 euros (\$1,200) a night. "This cyberattack was specifically designed to alter the payment validation system, and this is the first time we

have detected a crime using this method," Spain's National Police said.

Police said the man also consumed minibar items during his stays and occasionally left bills unpaid.

At the time of his arrest, he was staying at a luxury Madrid hotel with a four-night reservation totalling 4,000 euros.

Authorities said the hotel lost more than 20,000 euros.

The investigation began after an online booking website reported suspicious activity earlier this month.

Transactions initially appeared to be completed correctly, but the irregularity was only discovered days later, when the payment platform transferred the actual amount paid to the affected company.

UAE president re-emerges in video after rumours about health

Erdogan said Emirati leader had a "health problem"

Emirati President Mohamed bin Zayed Al Nahyan appeared in a meeting with a US senator yesterday, making a first appearance since rumours about his health spread following a now-deleted Turkish presidency statement.

Earlier this month, Turkey's President Recep Tayyip Erdogan went to Saudi Arabia and was meant to later visit the neighbouring United Arab Emirates, amid an ongoing rift between the two Gulf powers.

But on Sunday, Erdogan said he was postponing his Abu Dhabi trip because the Emirati leader had a "health problem" -- in a statement that was later deleted.

The incident fuelled rumours online about Sheikh Mohamed's health, with his Wikipedia page even briefly being edited to say he was dead.

On Wednesday, the presiden-

tial court shared video footage of the Emirati president, smiling alongside US Republican Senator Lindsey Graham during a meeting at Qasr Al Shati in Abu Dhabi.

The UAE's official WAM news agency also shared photographs of the meeting, in which Sheikh Mohamed appeared alongside Graham.

"To those who are perpetuating false narratives against the United Arab Emirates and President Sheikh @MohamedBinZayed personally, you are full of it," Graham said on X.

"I met with him today for an hour and a half. Not only is he alive, but he is also well and as sharp as I've ever seen him,"

added Graham, who said he was heading to Saudi Arabia next.

The Emirati leader's team on Saturday evening released photos taken the same day showing Sheikh Mohamed, known as MBZ, smiling and apparently in good health, with Sheikh Tamim bin Hamad Al Thani, the emir of Qatar.

Israeli minister pushes for 'emigration' of West Bank, Gaza Palestinians

A senior Israeli far-right minister vowed to encourage "emigration" from the Palestinian territories, despite mounting criticism of recent measures tightening Israel's control over the occupied West Bank.

Since last week, Israel has approved a series of initiatives backed by far-right ministers to consolidate control over the West Bank, including in areas administered by the Palestinian Authority under the Oslo Accords, in place since the 1990s.

"We will eliminate the idea of an Arab t***r state," far-right Finance Minister Bezalel Smotrich said at an event organised by his Religious Zionism Party late on Tuesday.

"We will finally, formally and in practical terms nullify the cursed Oslo Accords and embark on a path toward sovereignty, while encouraging emigration from both Gaza and Judea and Samaria," he said, using the Biblical term for the West Bank.

"There is no other long-term solution," added Smotrich, who himself lives in a settlement in the West Bank.

Smotrich was speaking at a vineyard near Ramallah, the seat of the Palestinian Author-

ity, where he presented what he called "Colonisation 2030", a campaign initiative ahead of national elections scheduled for later this year.

In addition to the finance portfolio, Smotrich serves on Israel's security cabinet, which takes key decisions regarding the West Bank, making him a central figure in efforts to expand settlements there.

The recently approved measures include launching a process to register land in the West Bank

as "state property" and allowing Jewish Israelis to purchase land directly. Until now, land acquisitions for settlers were typically carried out through intermediary companies.

The new measures repeal a decades-old law that barred Jews from directly purchasing land in the West Bank.

"This will allow Jews to purchase land in Judea and Samaria exactly as they do in Tel Aviv or Jerusalem," Smotrich said last week.

Global outrage

The steps are also set to increase Israel's control in parts of the West Bank where the Palestinian Authority currently exercises power.

Under the Oslo Accords, the West Bank was divided into areas A, B and C -- under Palestinian, mixed and Israeli governance respectively.

The West Bank would form the largest part of any future Palestinian state, but many on Israel's religious right view it as Israeli land.

The Oslo Accords were signed with the stated aim of paving the way for an independent Palestinian state.

Israeli NGOs have also raised the alarm over a settlement plan signed by the government which they say would mark the first expansion of Jerusalem's borders into the occupied West Bank since 1967.

The planned development, announced by Israel's Ministry of Construction and Housing, is formally a westward expansion of the Geva Binyamin, or Adam, settlement situated northeast of Jerusalem in the West Bank.

The new measures have triggered widespread international outrage.

Slovakia threatens Ukraine with reprisals over blocked pipeline

Ukrainian authorities say the Druzhba pipeline was shut down after being damaged

Hungary's Prime Minister Viktor Orban also accused Ukraine of "blackmail"

Slovakia's prime minister on Wednesday threatened to cut emergency electricity supplies to Ukraine if its neighbour does not reopen a pipeline that brings Russian oil to Slovakia and Hungary.

Prime Minister Robert Fico, who along with Hungary has remained close to Russia since its 2022 invasion of Ukraine, declared a state of emergency over oil supplies and told a press conference he had ordered the release of 250,000 tonnes of oil from emergency reserves.

Ukrainian authorities say the Druzhba pipeline, which runs from Russia through its territory to Slovakia and Hungary, was shut down after being damaged during a Russian attack near the Ukrainian city of Brody.

Fico, quoting Slovak intelligence, said the repair work had been finished. He accused Ukraine of blocking supplies as

a "blackmail" weapon against Hungary, which opposes Ukraine joining the European Union.

Hungary's Prime Minister Viktor Orban also accused Ukraine of "blackmail" in a social media post Wednesday.

Fico threatened to end electricity supplies to Ukraine when it needs emergency supplies after Russian attacks on its power stations.

"If the president (Volodymyr Zelensky) believes these supplies are not important, we can decide to withdraw from the electricity supply accord," Fico said.

Slovakia's ambassador in Ukraine had handed over an official note demanding an explanation for the cut in oil supplies, Fico added. The prime

minister said he would ask the European Union's executive arm to look into the case.

Orban said in his social media post that Hungary and Slovakia had requested that Croatia allow the supply of Russian oil through its Adria pipeline.

But Fico said there were "two problems" with this solution as the Adria pipeline's capacity had never been tested and the cost could be five times higher than for the Druzhba pipeline.

The European Commission said Tuesday it was in contact with all sides in the dispute and was ready to hold a meeting of its emergency oil supply co-ordination group. But it said there was no immediate risk as Hungary and Slovakia each have at least 90 days of emergency reserves.

First Ramadan after truce brings flicker of joy in devastated Gaza

Little Ramadan lanterns and string lights appeared on streets lined with collapsed buildings and piles of rubble in Gaza City, bringing joy and respite as Islam's holiest month began -- the first since October's ceasefire.

In the Omari mosque, dozens of worshippers performed the first Ramadan morning prayer, fajr, bare feet on the carpet but donning heavy jackets to stave off the winter cold.

"Despite the occupation, the destruction of mosques and schools, and the demolition of our homes... we came in spite of these harsh conditions", Abu Adam, a resident of Gaza City who came to pray, told AFP.

"Even last night, when the area was targeted, we remained determined to head to the mosque to worship God," he said.

A security source in Gaza told AFP Wednesday that artillery shelling targeted the eastern parts of Gaza City that morning.

The source added that artillery shelling also targeted a refugee camp in central Gaza.

Israel does not allow international journalists to enter the Gaza Strip, preventing AFP and other news organisations from independently verifying casualty figures.

In Gaza's south, tens of thousands of people still live in tents and makeshift shelters as they wait for the territory's reconstruction after a US-brokered ceasefire took hold in October.

Nivin Ahmed, who lives in

a tent in the area known as Al-Mawasi, told AFP this first Ramadan without war brought "mixed and varied feelings".

"The joy is stifled. We miss people who were martyred, are still missing, detained, or even travelled," she said.

"The Ramadan table used to be full of the most delicious dishes and bring together all our loved ones," the 50-year-old said.

Brazil's Lula leads major trade delegation to India

Brazil's President Luiz Inacio Lula da Silva arrived in New Delhi yesterday, leading a large delegation for talks with Prime Minister Narendra Modi including on rare earths and artificial intelligence.

Lula, who is travelling with more than a dozen ministers and a large business delegation that includes top CEOs of Brazilian companies, is also looking to increase trading opportunities with the world's most populous nation.

"India and Brazil share a close and multifaceted relationship," New Delhi's foreign ministry spokesman Randhir Jaiswal said in a statement, with photographs of Lula given a red carpet welcome from his aeroplane.

India, the world's most populous country with 1.4 billion people, is on track to become the fourth-largest economy.

The talks between fellow BRICS members -- New Delhi took over this year's presidency of the bloc from Brasilia -- are also expected to address global economic uncertain-

ty triggered by tariff policies under US President Donald Trump.

Lula and Modi will hold talks on Saturday, as Brazil pitches itself as a global alternative for rare earths in a market dominated by China.

Brazil's president will first attend a global artificial intelligence summit in New Delhi on Thursday, where he is expected to seek better regulation to stem AI disinformation.

Brazil is India's largest market in Latin America.

Russia, Cuba slam US in Moscow show of solidarity

Russia and Cuba yesterday slammed the US energy blockade of the Caribbean island in a show of solidarity in Moscow, where Havana's foreign minister was due to meet with President Vladimir Putin.

Cuba's top diplomat Bruno Rodriguez travelled to traditional ally Russia seeking help as his country reels from a severe fuel crisis -- intensified by Washington's de-facto oil blockade.

US President Donald Trump cut off key supplies of Venezuelan oil to Cuba after ousting Venezuela's Nicolas Maduro and has threatened sanctions on states that sell oil to Havana.

Rodriguez met with his Russian counterpart Sergei Lavrov ahead of seeing Putin, with the long-serving Russian diplomat

using Soviet-era language to criticise Washington.

"We call on the US to show common sense and refrain from the military-maritime blockade of the island of freedom," Lavrov said.

Havana has been allied to Moscow since the 1960s socialist revolution, relying on the Soviet Union for economic and political support for decades. The Kremlin maintained close ties with Cuba after the collapse of the USSR.

Moscow, Lavrov said, stood in "solidarity with our friends" as he called Cuba a "brotherly state to us", without making any concrete pledges of material support.

He condemned the United States for "after more than a 70-year blockade now even threatening to toughen their illegitimate and anti-humane actions."

Voters' list drawn from official commercial records

Election Chief Says 34,451 Commercial Registrations Eligible

The voters' list for the upcoming elections of the Bahrain Chamber of Commerce and Industry (BCCI) has been compiled directly from the official commercial registration database of the Ministry of Industry and Commerce, the chairman of the elections committee said on Tuesday.

Abbas Abdulmohsen Radhi, head of the committee overseeing elections for the Chamber's 31st Board of Directors, said the list was extracted from the ministry's Commercial Registration (CR) records in line with legal requirements to ensure accuracy and compliance.

The names of eligible voters were published on the Chamber's official website on Feb. 7, 2026, to allow members to review their information and sub-



mit correction requests where necessary, Radhi said.

He added that the committee

has initiated a comprehensive verification process to ensure that all data in the voters' reg-

ister fully matches the official CR records maintained by the ministry.

Members were urged to carefully review their details, particularly the inclusion of the legal representative's name and the accuracy of all required information. Any discrepancies or omissions must be addressed through formal requests submitted in accordance with the announced procedures, he said. "The objective is to safeguard the integrity of the electoral process and ensure the highest levels of accuracy and legal compliance," Radhi said.

The deadline for submitting requests for inclusion or correction is March 10, 2026, through an online form available on the Chamber's website.

Companies and establishments listed in the voters' register will be eligible to participate in the elections scheduled for Saturday, March 28, 2026, at the Isa Cultural Centre. Organisational and administrative preparations are under way to

ensure the process is conducted efficiently and transparently.

According to the latest figures, 34,451 commercial registrations are eligible to vote in the upcoming elections, reflecting a broad participation base for this electoral cycle.

Radhi also called on companies with commercial registrations nearing expiry to renew them within the legally prescribed timeframes before election day to safeguard their legal status and voting rights.

He added that, to date, the committee has not received any confirmed cases of discrepancies between the voters' register and the official commercial records, underscoring the accuracy of the procedures followed.

Radhi reaffirmed the committee's commitment to full compliance with applicable legal and regulatory frameworks, ensuring equal opportunities for all candidates and voters, and urged members to adhere to the announced deadlines to support a smooth electoral process.

German railway Deutsche Bahn hit by cyberattack

Berlin, Germany

A cyberattack against Germany's state-owned railway Deutsche Bahn briefly disrupted ticketing systems and timetable information services this week, the company disclosed yesterday.

The distributed denial of service (DDoS) attack caused problems with the railway's website and its widely used DB Navigator app on Tuesday afternoon.

The website and app issues were mostly resolved by Tuesday evening, but resurfaced again on Wednesday morning.

Deutsche Bahn is Germany's dominant rail service, operating both passenger and cargo trains as well as suburban commuter railways in many cities.

"Our defensive measures were effective in minimising the impact on our customers," Deutsche Bahn said.

The company has been in contact with Germany's BSI cybersecurity authorities, an interior ministry spokeswoman said Wednesday, adding that she could provide few additional details about the attack.

Whether it is a super-luxury address such as The Dahlias or a luxury development like One Midtown in New Delhi, the emphasis is on delivering a complete, globally comparable living experience in prime locations.

● **DLF has consistently seen strong NRI participation across its luxury launches. Could you share insights on the scale and nature of NRI investment, particularly from the UAE?**

UAE-based NRIs continue to be one of our most important and discerning buyer groups. More than a quarter of our NRI sales, this financial year has stem from UAE. Their decisions today are driven by the quality of the project, the credibility of the developer, service standards, and clarity on long-term value, rather than short-term or speculative considerations. At DLF, NRI sales have grown steadily over the past three financial years, increasing from about USD 240 million in FY23 to USD 408 million in FY24, and further to approximately USD 421 million in FY25. Our in-house hospitality and rental and re-trade have been a big differentiator, giving overseas buyers confidence in service quality, easy leasing, and

long-term asset performance.

● **How do you see the super-luxury segment evolving, and what can UAE buyers expect from DLF in the coming years?**

The super-luxury residential segment in India was virtually non-existent until six years ago. Historically, the purchase of a Rs. 100 crore home was a rare news, attracting national attention only once every few years. 

102-run victory over Namibia ensures Pakistan advances and eliminates the United States

Sahibzada Farhan hit a magnificent unbeaten century to help Pakistan seal the final Super Eight berth at the T20 World Cup with a thumping 102-run win over Namibia in Colombo yesterday.

Farhan scored 100 not out off 58 balls with four sixes and 10 fours as Pakistan posted 199-3 before they routed Namibia for 97 in 17.3 overs.

Pakistan's victory took them to six points from four games in Group A and eliminated the United States, who finished with four points.

The defending champions India, South Africa, Zimbabwe and the West Indies will play each other in the Super eights Group 1, hosted in India.

Pakistan join New Zealand, England and co-hosts Sri Lanka in Group 2, hosted in Sri Lanka.

After a morale-shattering 61-run defeat against India, Pakistan needed a victory to avoid an early exit, which was achieved with ease as spinners Usman Tariq (4-16) and Shadab Khan (3-19) tore through the Namibia batting.

Lauren Steenkamp scored 23 while Alexander Busing-Volschenk was the only

other batsman to reach double figures with 20.

"It is a complete performance," said a relieved Agha.

Farhan put on 40 for the opening wicket with Saim Ayub (14) before consolidating the innings during a 67-run second wicket stand with captain Salman Agha (38).

Pakistan also left out pace bowler Shaheen Shah Afridi after a poor show in the first three matches, including conceding 31 in two overs in the defeat against India on Sunday.

Farhan's ton means this is the first T20 World Cup in which three centuries have been scored.

Defending champions India beat a spirited Netherlands team by 17 runs yesterday ahead of their meeting with South Africa in the Super Eights of the T20 World Cup. India posted 193-6 and then kept the Dutch down to 176-7 with spinner Varun Chakravarthy returning figures of 3-14 in Ahmedabad to stay unbeaten in their four matches in Group A. But a tough test awaits the co-hosts at the same venue on Sunday when they face South Africa, who emerged top of a potentially tricky Group D that had New Zealand and Afghanistan. India finish top of their group ahead of arch-rivals Pakistan, but need to fix holes in their batting including the form of opener Abhishek Sharma, who fell for his third straight duck in the tournament.

Bahrain International Circuit (BIC) was bustling with activity yesterday as Formula 1 Aramco Pre-Season Testing 2026 resumed with the first of three final days of running.

Mercedes superstar George Russell pipped his McLaren counterpart Oscar Piastri by a mere one-hundredth of a second to top the overall timesheet. Both drivers hit the tarmac for the cooler evening runs along BIC's 5.412-kilometre track to shine brightest under lights.

Russell posted a pace-setting best lap time of 1min 33.459secs while logging a day one best of 76 laps after taking over for teammate Kimi Antonelli, who tested in the morning in their F1 W17 car.

Piastri ranked right behind Russell on times and completed 70 laps in McLaren's MCL40 car.

Ferrari's Charles Leclerc steered his SF-26 to third on the classification 0.280s off the leading mark. He set his best time in the morning session while racking up 70 laps. Reigning F1 Drivers' World Champion Lando Norris followed in fourth, also testing in daylight conditions, 0.593s from Russell while going for 54 laps. Antonelli joined Russell in the top five 0.699s from his teammate with 69 laps.

Isack Hadjar was the lone tester for Red Bull Racing to-



day and he finished sixth, 0.801s from the top, although only registered 66 laps in his RB22.

Completing the top 10 were Ferrari's Lewis Hamilton (+0.840s), Williams's Carlos Sainz (+1.654s) in the team's FW48, Franco Colapinto (+1.795s) in Alpine's A526, and Gabriel Bortoleto (+1.804s) behind the wheel of his Audi R26.

The Batak and stick catching games will be putting fans' reflexes to the test,

challenging hand-and-eye coordination in a pair of activities that F1's superstar drivers practice regularly to keep their skills razor sharp.

Aside from these, fans visiting BIC during testing will also have the chance to see a display of the new 2026 F1 car in its special Bahrain livery.

This year's F1 pre-season tests mark the sixth consecutive year that Sakhr has been selected as the venue for F1's most important preparation period ahead of the new world championship. Testing was first held in Bahrain in 2009 and then again in 2014. They have since taken place in Bahrain each year from 2021.

The tests will pave the way for the start of the new season, which will kick off with the Australian Grand Prix weekend, scheduled for 6 to 8 March. F1's star drivers and teams will then continue their battles with races in China and Japan, before returning to the Kingdom for the F1 Gulf Air Bahrain Grand Prix 2026 from 10 to 12 April – the fourth round of the 24-race world championship.
