### UAE announces social media ban for under-15s

The United Arab Emirates announced a social media ban for children under 15 on Thursday, joining a growing group of countries including Australia, Britain and Canada to take similar measures.



Social media platforms will have to monitor and disable accounts created by under-15s or risk being blocked, a cabinet resolution said, giving them a 12-month transition period.

“The resolution sets the minimum age for social media use at 15 years,” the official WAM news agency said, citing the cabinet resolution.

“Children below this age are prohibited from creating, using, or operating personal accounts on social media platforms.”

They are also barred from “accessing the full features of

such platforms, including social interaction, publishing, commenting, sharing, joining public groups, open channels, or any large-scale interactive spaces”, it said.

After Australia began a world-first social media bar for under-16s in December, a number of countries have followed suit including Britain, which announced a ban this week.

The UAE’s bodies controlling media and telecommunications have the authority to take all necessary measures against social media platforms in the event of non-compliance, WAM said.

These include “warning or partial or full blocking of platforms or the imposition of applicable administrative penalties”.

### Qatar Welcomes US-Iran MoU on De-escalation and Maritime Security

The State of Qatar welcomed the electronic signing of a Memorandum of Understanding (MoU) between the United States of America and the Iran aimed at addressing outstanding issues between the two sides, including the cessation of military operations and the assurance of freedom of navigation in the Strait of Hormuz.

In a statement, Qatar’s Ministry of Foreign Affairs described the agreement as a positive step reflecting both sides’ commitment to resolving disputes through dialogue

and peaceful means. It added that the MoU could help strengthen prospects for long-term regional stability and support economic growth at both regional and global levels.

The Ministry also expressed appreciation for the efforts of Pakistan and other regional and international partners that contributed to de-escalation efforts and helped bridge differences leading to the memorandum’s signing.

Qatar said the MoU provides a strong foundation for the next phase of discussions between Washington and Teh-

ran, urging all parties to maintain constructive engagement, continue diplomatic coordination, and work toward comprehensive and sustainable outcomes.

Reaffirming its position, Qatar stressed its continued support for mediation efforts aimed at enhancing regional security and stability. It reiterated that dialogue, peaceful resolution of disputes, and adherence to international law and good neighborliness remain essential to achieving lasting peace and shared prosperity.

### UNRWA Advisory Commission Warned of Deepening Financial Crisis

Ambassador Dr. Dawas Dawas, Assistant Secretary-General for Palestinian and Al-Quds (Jerusalem) Affairs, participated in the meeting of the Advisory Commission of the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), held in the Jordanian capital, Amman, amid escalating political, financial, and operational challenges facing the Agency.

During the sessions, Ambassador Dawas reaffirmed the Organisation of Islamic Cooperation’s (Organisation of Islamic Cooperation) firm and consistent support for UNRWA, in line with its successive resolutions and positions. He stressed the importance of preserving the Agency’s mandate, immunities, and privileges, highlighting its essential role under United Nations General Assembly resolutions. He further described UNRWA



as a key international witness to the Nakba and a central mechanism for protecting the rights of Palestinian refugees.

In a statement delivered on behalf of OIC Secretary-General Houssein Brahim Taha, he urged member states and donors to fulfil their responsibilities by providing sustained political, legal, media, and financial support. He emphasised that such backing is critical to ensuring UNRWA can continue delivering essential services to Palestinian refugees inside and outside camps across its five fields of

operation, particularly in the occupied city of Al-Quds.

The UNRWA Advisory Commission convenes periodically with participation from 29 member states, along with four observers: the State of Palestine, the Organisation of Islamic Cooperation, the League of Arab States, and the European Union. The meeting reviewed deteriorating conditions faced by Palestinian refugees, as well as the Agency’s growing financial deficit and widening operational pressures across all areas of activity.
