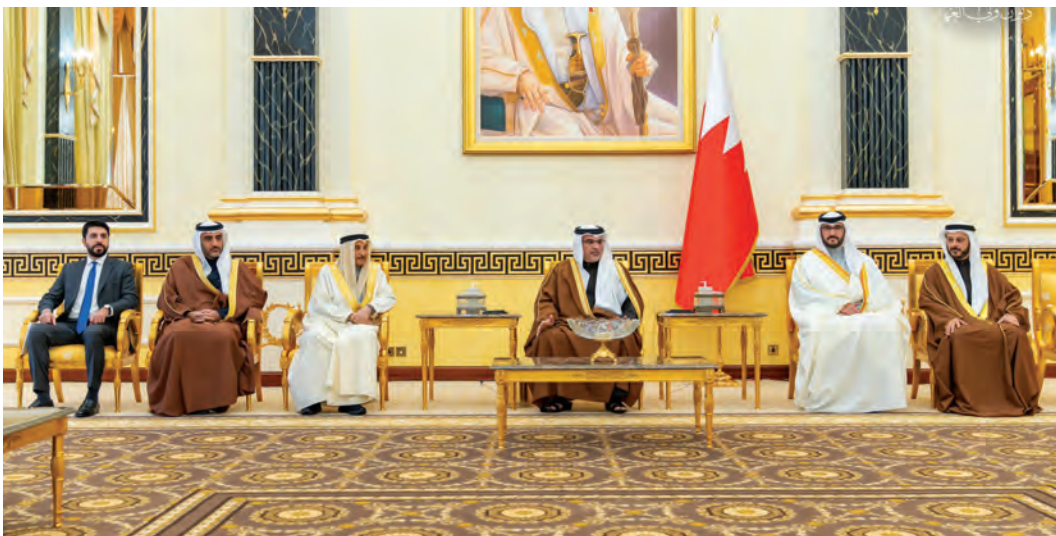

Awareness programmes underway

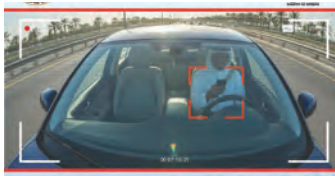
First phase of smart camera system starts Feb 1

The Ministry of Interior announced that the General Directorate of Traffic will begin operating the first phase of the smart camera system on 1 February 2026, following confirmation of the system's technical

readiness and its efficient operation under various conditions.

The ministry noted that awareness programmes will be intensified in the coming days, focusing on the main violations that the system can detect, in a move aimed at enhancing road safety.

It explained that the new phase relies on the actual monitoring of violations through an advanced surveillance system.

The most prominent violations that can be detected by the smart cameras include exceeding the speed limit, running red lights, and using the emergency

vehicles lane (yellow lane).

They also include using a handheld mobile phone while driving and failure to wear seatbelts by the driver and front-seat passenger.

Other violations include allowing a child to sit in the front seat.

Tubli Bay treatment plant expansion due by year-end

Work is under way to expand wastewater treatment and improve water flow in Tubli Bay, the Minister of Oil and Environment, His Excellency Dr Mohammed bin Mubarak bin Daina, told Parliament yesterday, saying the problem is long-running and cannot be denied.

Answering a question from MP Khalid Buanaq about foul smells in the bay, H.E. Bin Daina said the government accepts there is an environmental problem and that dealing with it means looking back at how it built up over many years, rather than treating it as a new issue.

He told MPs the government is expanding a treatment plant to a capacity of up to 1,000 cubic metres, with completion expected by the end of this year.

Existing stations at the same site are also being upgraded

using newer technology, he said. H.E. Bin Daina said he is following the file directly and that the Cabinet receives regular updates, including monthly reports, on marine conditions and water quality in Tubli Bay. He said the government is taking responsibility and making decisions that match the scale of the task.

He pointed to steps taken to improve circulation, including widening and deepening the Ma'ameer channels, changes to the watercourse near Sabah Al Ahmed Highway, and new openings and channels to help water move through the bay. H.E. Bin Daina said further work has included widening channels near Alba and dredging to widths reaching 300 metres, with planned depths aimed at improving currents.

The minister said the projects have cost the state millions of dinars and were carried out 'for the health of residents' and the long-term public interest.

Starlink high-speed wi-fi to roll out on Gulf Air fleet

Bahrain's national carrier, Gulf Air, has announced a historic partnership with SpaceX's Starlink service to introduce high-speed Wi-Fi on its flights, offering passengers a futuristic flying experience.

The installation process is set to begin this year, with the airline aiming to have the first aircraft online by mid-year.

Martin Gauss, Chief Executive Officer of Gulf Air, told The Daily Tribune, "We are currently working on the approval process, and the next step could start by the middle of this year."

Approvals

He added that the implementation timeline will depend on regulatory approvals for different aircraft types.

"Some aircraft types haven't been done yet, and Gulf Air is

among the first airlines to adopt Starlink. Each airline requires unique certification, which is beyond our control," Gauss explained.

He confirmed that the Airbus A320 will be the first Gulf Air aircraft to receive Starlink

Wi-Fi.

Agreement

Under the agreement, Starlink will initially operate on Gulf Air's Airbus A320 fleet before being rolled out across the airline's entire network.

The state-owned carrier will offer the service free of charge to passengers.

Gulf Air Group Chairman Khalid Hussein Taqi, highlighted that introducing Starlink across Gulf Air's fleet reflects the airline's ongoing commitment to elevating the passenger experience and providing advanced connectivity on every flight.

Two convicted of embezzling passenger money

The High Criminal Court has sentenced two public employees to five years in prison each after convicting them of abusing their positions and embezzling money from a passenger at Bahrain International Airport, the Deputy Head of the Financial Crimes and Money Laundering Prosecution announced.

The court also fined each defendant 3,500 Saudi riyals, or its equivalent in Bahraini dinars, and ordered them to repay the same amount to the victim.

According to the prosecution, the case began after a complaint was filed with the Public Prosecution by the General Directorate for Anti-Corruption and Economic and Electronic Security.

The victim reported that while he was at Bahrain International Airport, the two defendants stopped him, took him to a restroom closed for maintenance, and searched him.

After he later counted his money at the boarding gate, he discovered that part of it was missing.

The passenger returned to Bahrain and filed a formal complaint. The defendants were summoned by their employer.

Marine balance

Fishing net limits cut as Minister defends rules, MP cites fishermen’s losses

Oil and Environment Minister, His Excellency Mohammed bin Mubarak bin Daina, told Parliament yesterday that new fishing rules agreed with MPs have met demands to nationalise marine fishing.

MP Mohammed Al Rifai said recent decisions have hit fishermen’s incomes and left many unsure what they mean in practice.

Answering Al Rifai’s question on the number of valid fishing licences, H.E. Bin Daina said the ministry had worked with Parliament on the decisions and kept in touch with fishermen’s societies before taking them.

” Bahrain’s marine wealth and the public link to the sea and fishing remain part of the country’s living heritage. Licence numbers show the scale of that link.

Cooperation

“I thank MP Mohammed Al Rifai for his co-operation with fishermen’s societies,” he said, adding that he speaks directly with society heads, including the Professional Fishermen Society and area groups such as the Galali Fishermen’s Association and the Sitra Fishermen’s Association, through meetings and consultations ahead of any move.

H.E. Bin Daina said some steps could affect parts of the sector for a limited time, but insisted they were taken for the sea and for fishermen in the long run.

He gave net rules as one example, saying the permitted

length of the ghezl net had been cut from 1,200 metres to 800 metres, while saying this had not changed the amount of fish reaching markets.

Trawling

He also pointed to bottom trawling, known as karaaf, saying it harmed the marine environment and that a ban has been in place since 2017.

H.E. Bin Daina said the ban affected some seafarers, but that most were paid compensation ranging from 26,000 to 32,000 dinars in return for shrimp-fishing licences.

Those who switched their licence to fish fishing received 4,000 dinars, he said, adding that the number of beneficiaries was sizeable.



The minister said the government treats fishermen as partners and draws on their experience, adding that fishermen’s societies and the UN’s Food and Agriculture Organization helped shape the rules that govern fishing methods.

Pause

He said fish stocks had improved, pointing to there being no shortage of fish in markets, and said a two-month pause on fishing saafi and andaq had not affected households, with other options available during that period.

H.E. Bin Daina said bans during breeding seasons are aimed at boosting stocks.

Dates set for BD11.2m sewerage, and road works

More than BD11.2 million worth of sewerage work is being built or readied for the Fourth Constituency in the Northern Governorate, the Ministry of Works has told Parliament, with some schemes running into 2027.

In a written reply to MP Hassan Ebrahim, the ministry said the programme covered sewerage networks, road upgrades and paving, along with follow-up work linked to the Ishbiliya housing project.

It said start dates for some road schemes would depend on completing technical steps, securing funding and gaining clearances from relevant service bodies.

The ministry put the total cost of sewerage projects now under way, and due for completion in 2026 and 2027, at about BD11,228,139.

One of the biggest jobs is in Abu Quwwa, Block 457, where a new sewerage network is being built at a cost of BD5,827,176.

Work began in May 2025 and the ministry expects it to finish in the fourth quarter of 2027.

Progress stands at 9.5 per cent, it said.

The scheme includes one pumping station and about 23-kilometre long of sewer lines.

‘In pain and sorrow’

Deputy Speaker blames ‘laxity and exceptions’ for another fatal road accident

Driving culture and inexperience behind incidents

Bahrainis are “in pain and sorrow” after a fatal road incident happened again for the second time in a short period, Parliament’s First Deputy Speaker Abdulnabi Salman told members yesterday, as the government rejected claims that enforcement has been lax.

Speaking during the Parliament session, Salman said the traffic law was not being enforced as required, blaming what he called “laxity and unjustified exceptions”.

He said there had been shortcomings in dealing with road crashes and reckless behaviour, especially among young people, and called for the law to be en-

forced in practice, warning that the site involved draws thousands of visitors each week.

Catastrophe

He described the incident as

“a catastrophe and a major loss for Bahrain”, and offered condolences to the Al Shuwaikh family and to Bahrainis.

The Minister of Parliamentary Affairs, His Excellency

Ghanim bin Fadhl Al Buainain, pushed back, saying the relevant authorities were applying the law within its limits and that there was no leniency on penalties.

“The relevant authorities enforce the law within its limits, and there is no laxity when it comes to penalties,” he said, while thanking both the Shura Council and Parliament for passing the traffic law.

Factors

H.E. Al Buainain said many factors can lie behind such incidents, including driving culture and inexperience, but insisted there was no excuse for dangerous conduct.

“There is absolutely no justification for anyone,” he said.

Salman also raised delays affecting draft laws in committees, saying some were ready but still held up, and urged quicker work to merge and pass agreed amendments as the Council moves into its final legislative term.

Parliament push to develop public libraries

The Council of Representatives approved a proposal for the development of public libraries and the establishment of a national knowledge bank to support researchers and students, following a report submitted by the Services Committee.

The proposal, presented by MP Muneer Ebrahim Suroor, received parliamentary backing despite differing views expressed during the debate.

The proposal seeks to expand access to academic studies and scientific research through modernised public libraries and a centralised national knowledge platform.

Supporters argued that the initiative would strengthen reading culture, support school and university students, and enhance research capabilities, describing it as a long term investment in education and human development.

Space

MP Suroor, who submitted the proposal, stressed that public libraries remain a vital educational space, particular-

ly for students and researchers who require reliable, organised, and locally relevant sources.

He underlined that the proposal aligns with constitutional obligations requiring the state to support science, research, and cultural services, and to ensure equal access to knowledge across all governorates.

During the session, MP Hamad Al Doy expressed opposition to the proposal, stating that most academic material is now readily available through the internet and artificial intelligence, which he described as a vast and accessible library of knowledge.

He argued that Bahrain faces more urgent challenges that should take priority, suggesting that resources be directed towards addressing pressing social and economic issues.

In its report, the Services Committee explained that it had reviewed the proposal over two meetings during the sixth legislative term, with discussions held in the presence of the proposing MP and the legal adviser to parliamentary committees.

Major drug seizure



The Ministry of Interior confirmed that the Anti-Narcotics Directorate of the General Directorate of Criminal Investigation and Forensic Science, in cooperation with Customs Affairs, has arrested seven individuals, including three women of various nationalities, in separate incidents for possession of narcotic substances weighing approximately 10 kilograms and valued at more than BD160,000. The General Directorate of Criminal Investigation and Forensic Science said that the seized items were secured and confiscated, all necessary legal procedures were taken, and the cases were referred to the Public Prosecution.

Discussion

At the heart of the discussion was the role of DANAT, whose core mandate focuses on preserving Bahrain’s natural pearl beds, maintaining the quality of pearls, and ensuring their long-term abundance.

These efforts underline the importance of striking a bal-

ance between economic growth and environmental stewardship in an industry intrinsically linked to nature.

Speakers emphasized that sustainability is no longer a concept confined to philanthropy but a fundamental pillar of modern business strategy.

With nearly half of the world’s GDP dependent on nature, understanding how industries impact the climate and ecosystems has become critical.

This shift is further reinforced by a new generation of consumers who are actively questioning whether products are sustainably sourced and responsibly produced.

MPs back child protection measure

The Council of Representatives has approved, by majority vote, a parliamentary proposal aimed at protecting the rights of minor children during ongoing family disputes, referring the recommendation to the Government for consideration and implementation.

The proposal, reviewed by the Legislative and Legal Affairs Committee, allows mothers and grandparents to complete official government transactions on behalf of minors while

cases remain pending before the courts. MPs stressed that legal disputes between adults must not result in administrative or humanitarian harm to children.

Presenting the proposal, MP Jalal Kazem Al Mahfood delivered a key intervention that shaped the debate, warning that children often become unintended victims of procedural rigidity during prolonged family disputes. He said minors are frequently deprived of timely access to passports, residency documents, healthcare registrations, and educational services

due to the absence of interim authority while cases remain unresolved.

Al Mahfood told the committee that family disputes may take months or years to reach final rulings, while children’s daily needs remain immediate and continuous.

He stressed that the proposal does not interfere with judicial authority or influence court outcomes, but instead establishes a temporary and regulated mechanism to ensure that minors’ affairs proceed without disruption until judgments are issued.

Two convicted of money laundering

The Deputy Chief Prosecutor of Financial Crimes and Money Laundering said that the First High Criminal Court has convicted two defendants

of laundering money obtained from an online fraud crime.

The court sentenced the first defendant to five years in prison and the second defendant to eight years in prison.

Both were also fined

BD200,000.

The court ordered the confiscation of BD36,830.816, or any other money owned by the defendants equal to the value of the crime proceeds.

According to the prosecution, the case began after a report

from the National Financial Intelligence Center.

Investigations showed that an online fraud was committed against a foreign company for more than 74,000 Bahraini dinars by the first defendant while he was outside Bahrain.

Hybrid cars top choice for consumers in Europe in 2025

Hybrid-electric vehicles dethroned purely petrol-powered cars as the top power option among consumers in Europe last year, data showed yesterday. Some 10.8 million new vehicles were registered in 2025 in the Euro-



pean Union, an increase of 1.8 percent from the previous year, according to the European Automobile Manufacturers' Association (ACEA). New car sales "remain well below pre-pandemic levels", however, the trade association said in a statement. Despite the only modest overall sales growth, consumers

continued to shift towards hybrid and battery-electric vehicles. Sales of hybrid-electric vehicles climbed by 13.5% last year to account for 34.5% of total sales in the EU last year, putting them ahead of petrol cars at 26.6%. Meanwhile, sales of battery-electric vehicles jumped by 30 percent to account for 17.4% of overall sales, though the ACEA

noted that the gain was from a weak performance in 2024 and needs to rise further to stay on track with the EU's transition goals. Sales of plug-in hybrids also rose, but sales of petrol and diesel vehicles dropped. The combined market share of petrol and diesel cars fell to 35.5%, down from 45.2% in 2024. Volkswagen Group saw sales

rise by 5.5% last year to increase its lead as the top-selling carmaker in Europe. France's Renault saw similar growth, but Stellantis, which owns several European brands such as Peugeot and Fiat, saw sales slide by 4.7%. Chinese carmaker BYD tripled its sales in the EU last year, although from a small base. China's SAIC Motor, which

owns the MG brand, saw sales rise by a third. Sales of Teslas fell by nearly 38% last year as the electric car brand has suffered reputational damage in Europe from its association with billionaire Elon Musk, who backed US President Donald Trump before a falling-out, and who has endorsed Germany's far-right AfD party.

What benefits for the EU?

Indian tariffs on more than 90% of EU goods will be removed or cut.

For example, India will progressively reduce levies to between 20 and 30% on European wines, down from 150% before the agreement.

Beer tariffs will drop to 50% from 110%, while spirits will see future levies of 40%, down from up to 150%.

India will also remove tariffs on EU olive oil -- a major export from Spain, Italy and Greece -- fruit juice, non-alcoholic beer and processed food including bread, pasta, chocolate and pet food.

In a welcome move for one of the bloc's biggest sectors and especially Germany, tariffs on cars will be gradually lowered from a top rate of 110% to as low as 10% -- with a quota of 250,000 vehicles.

And India will eliminate tariffs on aircraft -- a potential boon for pan-European aerospace group Airbus -- as well as cutting levies to zero on most machinery, medical equipment, chemicals and pharmaceutical products.



How does India benefit?

According to Brussels, the EU's imports from India comprise mainly machinery and appliances, chemicals, base metals, mineral products and textiles.

India said the EU would immediately eliminate duties on products making up the majority of its exports including textiles, leather and footwear, tea, coffee, spices, sports goods, toys, gems and jewellery, and certain marine products.

And the EU agreed to phase out tariffs for processed food items as well as arms and ammunition, among other goods.

Steel was a thorny issue in negotiations since India is a major exporter. Brussels says the steel makes up seven percent of total Indian exports to the EU.

Under the deal, India will benefit from a duty-free quota of 1.6 million tonnes, and New

Delhi will relinquish its retaliation rights under the World Trade Organization, a senior EU official said.

Another sticking point for India was the EU's carbon border tax, which aims to ensure foreign producers pay a carbon cost similar to what European companies already pay under the bloc's internal emissions trading system.

Under the deal, the EU agreed to launch a technical dialogue on the tax if needed, and vowed not to treat any other EU partner better than India.

The EU has also promised to make it easier for skilled Indian workers to work in the 27-country bloc, agreeing to a memorandum of understanding on mobility covering issues related to seasonal workers, researchers and students, the EU official said.

What doesn't the deal include?

Sensitive agricultural products are excluded from the new deal.

The senior EU official said there were no concessions for sugar, ethanol, rice, soft wheat, beef, chicken meat, milk powders, bananas, honey or garlic.

He also said that unlike deals the EU has struck with other partners, there were no chapters on government procurement, on energy and raw materials, or on the liberalisation of investment in manufacturing sectors.

India also opposed any chapter on "sustainable development where we focus

on social rights and also environmental issues", the official added.

The two partners are discussing a separate agreement on Geographical Indications, the intellectual property rights that link a product's qualities, reputation or features to its place of origin.

This "will help traditional EU farming products sell more in India, by removing unfair competition in the form of imitations", the EU executive said.

India said the deal safeguarded sensitive sectors including dairy, cereals, poultry, soybean meal and certain fruits and vegetables.

EU, India agree 'mother of all' trade deals

The EU has eyed India -- the world's most populous nation -- as an important market for the future.

"Europe and India are making history today," von der Leyen said in a statement, a day after she and Costa were feted as guests of honour at India's Republic Day parade.

"We have created a free trade zone of two billion people, with both sides set to benefit."

'Increasingly insecure world'

EU officials said the deal was the most ambitious India had ever agreed, and European companies would benefit from so-called "first mover advantage".

Europe's key agricultural, automotive and service sectors stand to gain.

But sensitive agricultural sectors, such as beef, rice and sugar whose inclusion in an earlier deal struck with South American bloc Mercosur sparked farmers' anger in Europe, were left out of the agreement.

New Delhi sees the European

bloc as an important source of much-needed technology and investment to rapidly upscale its infrastructure and create millions of new jobs.

It also includes a security partnership, providing "new opportunities" for defence companies, Modi said.

"We are not only making our economies stronger -- we are also delivering security for our people in an increasingly insecure world," von der Leyen said, speaking alongside Modi after exchanging agreements.

"By combining these strengths, we reduce strategic dependencies, at a time when trade is increasingly weaponised," she added.

Bilateral trade in goods reached 120 billion euros (\$139 billion) in 2024, an increase of nearly 90 percent over the past decade, according to EU figures, with a further 60 billion euros (\$69 billion) in trade in services.

Under the agreement, India is expected to ease market access, and European firms will get privileged access to the Indian financial services and maritime transport market, the bloc said.

'Highest level of access'

Tariffs on cars will be gradually lowered from a top rate of 110% to as low as 10% -- with a quota of 250,000 vehicles -- while duties on wines progressively go down from 150 percent to as low as 20 percent.

Currently at 50%, tariffs on processed foods -- including pasta and chocolate -- will be eliminated, according to the EU.

Von der Leyen said she expected exports to India to double, and that the EU would "gain the highest level of access ever granted to a trade partner in the traditionally protected Indian market".

For India, it would boost sectors including textiles, gems and jewellery, and leather goods, as well as the service sector, Modi said.

The accord comes as both Brussels and New Delhi seek to open up markets in the face of US tariffs and Chinese export controls.

"The unprecedented preferential access secured for over 99 percent of Indian exports is a game-changer for Indian industry," said Chandrajit Banerjee, director general, Confederation of Indian Industry.

US monster storm kills 30

Deadly plane crash

More than half a million Americans woke up without power yesterday, as freezing temperatures gripped swathes of the country in a monster storm that has killed at least 30 people.

A frigid, life-threatening Arctic air mass could delay recovery as municipalities from New Mexico to Maine tried to dig out following the storm, which dropped a vicious cocktail of heavy snow and wind, along with freezing rain and sleet.

Forecasters warned that much of the northern half of the country will see temperatures that are "continuously below freezing through February 1," the National Weather Service said in an X post.

It added that "record low temperatures" hit southern states, which are unaccustomed to intense winter weather.

While skies began clearing in parts of the country, relentless snowfall in the northeast meant parts of Connecticut saw over 22 inches (56 cm) of snow, with more than 16 inches (40.6 cm) recorded in Boston, Massachusetts.

The storm was linked to at least 30 deaths, according to a compilation of state government and local media reports, with causes including hypothermia as well as accidents related to traffic, sledding, ATVs and snowplows.

Seven people were killed when the small plane they were traveling in crashed while taking off in a snowstorm in Bangor, Maine, the Federal Aviation Administration said.

One man in New Jersey was found in the snow unresponsive with a shovel in his hand.

In New York City, eight more people were found dead amid plummeting temperatures, and an investigation to determine the causes was underway. It was not known if all of these fatalities were storm-related.

Electricity began blinking back on across the south but as of Tuesday morning more than 540,000 customers remained without it, according to the tracking site Poweroutage.com. Tennessee, Texas, Mississippi and Louisiana in the south were especially impacted.

More than 9,000 flights were disrupted, as the storm para-

lyzed transportation across the country.

"We don't know if we are going to make it or not. We've been here since Sunday," Alan Vazquez told AFP at Dallas-Fort Worth airport in Texas.

Nashville Mayor Freddie O'Connell told journalists that trees were continuing to fall under the weight of encrusted ice across the Tennessee capital city, sometimes knocking out power that had already been restored.

Nashville and other municipalities across the country were establishing emergency warming shelters.

NWS meteorologist Allison Santorelli told AFP this storm recovery was particularly arduous because so many states were impacted -- meaning northern states with more winter supplies were unable to share their resources with less-prepared southern regions.

"A lot of those locations don't have the means or the resources to clean up after these events," she said. "We're particularly concerned about the folks in those areas that are without power right now."

North Korea fires ballistic missiles towards Sea of Japan

North Korea fired what appeared to be two ballistic missiles towards the Sea of Japan yesterday, Tokyo said.

South Korea's Joint Chief of Staff also said it had detected a "projectile" being fired towards what Seoul calls the East Sea.

Japan's coast guard, citing the defence ministry, said it had detected two ballistic missiles and that both were estimated to have already splashed down.

Japanese news agency Jiji Press reported the two missiles had landed outside of the country's Exclusive Economic Zone,

citing defence ministry sources.

The test is Pyongyang's second of the month, following a salvo of missiles fired hours before South Korea's leader headed to China for a summit.

It comes a day after a high-level visit to Seoul by the Pentagon's number three official Elbridge Colby, who hailed South Korea as a "model ally".

North Korea has stepped up missile testing significantly in recent years.

Analysts say this drive is aimed at improving precision strike capabilities, challenging the United States as well as South Korea, and testing weapons before potentially exporting them to Russia.

Pyongyang is also set to hold a landmark congress of its ruling party in the coming weeks, its first in five years.

News in brief

◆ **Iran has warned of "destructive consequences"** if the country's Islamic Revolutionary Guard Corps is listed as a terrorist organisation by the EU, state media reported yesterday, after Italy's foreign minister urged Brussels to go ahead with the designation. Rome's top diplomat Antonio Tajani on Monday said he would propose the idea "in coordination with other partners" at a meeting of EU foreign ministers in Brussels later this week. It comes after unrest erupted in Iran last month over the rising cost of living which, according to officials, began as peaceful demonstrations before turning into what they described as "foreign-instigated riots" involving killings and vandalism. Tehran summoned Italy's ambassador to the Islamic republic, Paolo Amadei, and condemned Tajani's remarks as "irresponsible", warning of "destructive consequences" if the bloc went ahead with the move, the official IRNA news agency reported.

◆ **French aircraft carrier heads to North Atlantic amid Greenland tensions**

◆ **The flagship** of the French Navy, the Charles de Gaulle aircraft carrier, yesterday set course for the Atlantic, the defence ministry said, after the United States and Europe butted heads over Greenland. On Wednesday, French President Emmanuel Macron is to meet the leaders of Denmark and Greenland in Paris, his office said. European powers rallied together when US President Donald Trump this month undermined the transatlantic alliance by threatening to seize the autonomous Danish territory. Greenland is strategically located between the Arctic Ocean and the North Atlantic Ocean. The French defence ministry did not specify where the Charles de Gaulle was being deployed. But sources familiar with the matter told AFP that the aircraft carrier was heading to the North Atlantic, which has been at the heart of the geopolitical tensions.

◆ **China promised** yesterday to provide Cuba with "support and assistance" in the face of repeated threats from the United State, which weeks ago removed Havana's ally in Venezuela Nicolas Maduro. Beijing and Havana are longtime socialist allies, and Chinese authorities have consistently opposed the economic blockade imposed on the island for decades by the United States. Tensions have intensified this month as US President Donald Trump warned that Cuba "is ready to fall". Trump has told Havana to "make a deal" or pay a price similar to Venezuela, whose former leader Maduro was captured in a US bombing raid on January 3 that killed dozens of people.

India's Adani signs pact with Brazil's Embraer to build planes

India's Adani Group and Brazilian plane maker Embraer signed a deal yesterday to build aircraft in India, as the world's most populous nation seeks to become a global aviation hub.

The two firms aim to establish an "assembly line", according to a joint statement, and will collaborate in airplane manufacturing, the broader aviation supply chain and pilot training.

"The proposed ecosystem is geared towards supporting domestic demand while generating significant direct and indirect employment," the statement said, without providing financial details.

The pact offers Adani -- a sprawling ports-to-power conglomerate run by billionaire

Gautam Adani -- a key opportunity to boost its aerospace business.

For Embraer, the world's third-biggest aircraft maker, the deal gives it a foundation to expand its growing footprint in India.

India's air force currently operates Embraer jets including the Legacy 600 and the "Netra" AEW&C aircraft based on its ERJ145 platform.

"India is a pivotal market for Embraer," Arjan Meijer, president and CEO of Embraer Commercial Aviation, said in the statement, adding the partnership combined the firm's aerospace expertise with "Adani's strong industrial capabilities".

Embraer said in October that it ended the third quarter of 2025 holding unfilled orders for 490 aircraft after closing several major deals.

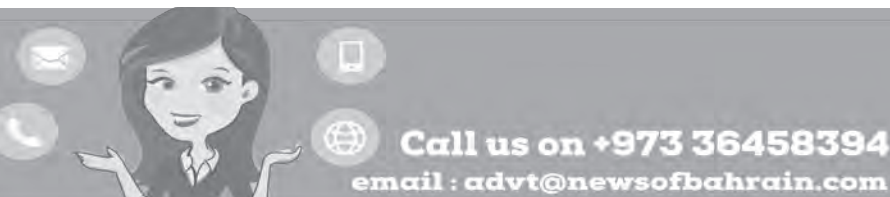

Bahrain secured a rare dual leadership result at the International Sport for All Federation's global congress in Italy, with two national representatives winning senior positions at a time when the federation is expanding its international footprint and adopting a new growth-focused strategy.

AI on the touchline

● **How ChatGPT Shaped Robert Moreno's Time at Sochi**

Robert Moreno's brief spell at Russian Premier League side Sochi has taken on a surprising new dimension months after his departure, with revelations that artificial intelligence played a central role in his daily work. Moreno, former Spain head coach who guided La Roja through Euro 2020 qualifying, was dismissed in September, with poor results initially cited as the reason.

However, club officials later confirmed that his reliance on ChatGPT for training plans, match preparation, travel logistics, and even player recruitment had raised internal concerns.

Former Sochi general director Andrei Orlov said Moreno regularly turned to the AI tool, which became a central pillar of his methods. One incident particularly alarmed the club: a travel schedule for a long trip to Khabarovsk would have left players without sleep for 28 consecutive hours. Although the plan was adjusted, it highlighted Moreno's heavy dependence on the technology.

AI also influenced transfers. When Sochi sought to strengthen their attack, Moreno input performance data on several striker options into ChatGPT, which recommended Artur Shushenachev. It was a verdict that strongly guided the club's decision.

While officials did not op-

pose technology as a support tool, concerns grew over how much responsibility Moreno delegated to AI. "It's a tool like any other. Why not use it?" Orlov said. "But for Moreno, GPT became one of the main ones."

Moreno, however, denies the reports. In an open letter to Spanish media, he stated: "I have never used ChatGPT or any AI to prepare matches, decide line-ups, or choose players. That is completely false." He stressed that all sporting decisions were made by him and his staff, with tools like GPS, Wyscout, video analysis, and scouting platforms serving only to assist.

Ultimately, disappointing results, unconventional methods, and internal disagreements proved decisive. As clubs increasingly embrace data and technology, the Sochi case highlights the fine line between innovation and over-reliance in modern football, while raising questions about perception versus reality in AI's role on the touchline.

Mahrouk's Brace Boosts Muharraq Title Defense

Matchday 13 of the Nasser Bin Hamad Premier League continued last night with Muharraq delivering a comfortable 3-0 win over bottom side Al Shabab at Khalifa Sports City, keeping the pressure firmly on leaders Al Khaldiya.

The champions wasted little time asserting themselves and nearly struck inside 12 minutes when Tobares' cross found Soufiane Mahrouk, whose effort crashed against the post, but the Moroccan winger would not be denied for long. Three minutes later, Arthur Rezende split the defence with a beautiful outside-of-the-boot pass, allowing Mahrouk to cleverly let the ball run across his body before finishing calmly. A brief VAR check for offside followed, but the goal stood.

Al Shabab struggled to respond, and Muharraq doubled their advantage early in the second half. In the 46th minute, Edimar da Costa flicked on a header from midfield, which Hussain Abdulkarim met with determination, outmuscling Chikamuso Okchukwu before stretching to prod the ball into the corner.

Nandinho's side then sealed the result in the 70th minute as Mahrouk completed his

brace. Algerian winger Samy Frioui broke down the flank and squared for the unmarked Mahrouk, who finished confidently to put the contest beyond doubt.

The result keeps Muharraq second on 30 points, level with Al Khaldiya but trailing on head-to-head, while Al Shabab remain rooted to the bottom of the table on six points.

Earlier at Shaikh Ali bin Mohammed Al Khalifa Stadium, Al Hidd and Bahrain Club played out a 1-1 draw. Oussema Belatrech gave Al Hidd an early lead in the sixth minute, controlling a long ball from deep before creating space and firing a superb strike into the right corner from outside the box.

Bahrain Club found the equaliser in the 71st minute through Jassim Mohammed. Captain Abdulla Al Zayed delivered a dangerous cross from the right, Sultan Al Salatneh's sliding effort rattled the crossbar, and Mohammed rose highest to head in the rebound.

The draw leaves Al Hidd seventh on 15 points, while Bahrain Club sit 11th with seven.

Matchday 13 concludes tonight as Sitra face Riffa at Khalifa Sports City and A'ali take on Al Najma at Shaikh Ali bin Mohammed Al Khalifa Stadium, with both matches kicking off at 7pm.

Arteta issues rallying cry after Arsenal wobble

Mikel Arteta promised that Arsenal would play with "courage and conviction" for the rest of the season after their surprise defeat by Manchester United slowed their Premier League title charge.

Arsenal, who remain four points clear of second-placed Manchester City, host Kazakhstan's Kairat Almaty in the Champions League on Wednesday, aiming to complete the tournament's league phase with a perfect record.

The Gunners, who have seven wins out of seven in Europe this season, have already secured a place in the last 16, meaning they avoid a potentially tricky play-off next month.

They are also still alive in both domestic cup competitions.

Arsenal boss Arteta was asked at his pre-match press conference yesterday about his team's reaction to Sunday's surprise 3-2 defeat against United -- a first home loss of the season.

"The reaction has been ex-

cellent," said the Spaniard. "We took a moment to bring the temperature down, to pause and to reflect and ask two questions.

"One is, how do we feel and how do I feel myself? And then, how we are going to live the next four months?

"And it was so encouraging and beautiful because what came out of that is very simple -- we have earned the right to be in a great position in four competitions."

Arsenal's slip-up against Michael Carrick's resurgent United followed 0-0 draws against Liverpool and Nottingham Forest.

But Arteta promised that

the Gunners would be fearless as they chase a first Premier League title since 2004.

"In the next four months, we are going to live and play with enjoyment, with a lot of courage and with the conviction that we are going to win it," he said.

"And this is going to be the mindset and where we are going to put the energy and I'm just hoping that everybody that is related to this club, especially our supporters, jump on the boat."

William Saliba and Jurrien Timber are not available to face Almaty due to "slight niggles" while Mikel Merino and Declan Rice are suspended.

Bahrain's warriors trash Japan to reach Asian final

Abdulhussain's goalkeeping masterclass steals the show

Bahrain's men's handball team booked their place in the final of the 22nd Asian Men's Handball Championship with a 35-25 victory over Japan in Kuwait City. Both teams had already secured qualification for the 2027 IHF Men's Handball World Championship in Germany, but the semi-final offered a route to the continental showpiece, and the "warriors" delivered a dominant performance. Bahrain will take on the Qataris in the final, buoyed with confidence after having already defeated them in the preliminary rounds.

Yesterday's first half saw Bahrain rely heavily on Mohammed Habib Nasser, who carried the attacking load early on. He levelled the score at 7-7 in the 12th minute and soon after converted from seven metres to make it 10-8. Captain Hussain Al Sayyad endured an unusually quiet opening period but produced a crucial counterattack to stretch the lead to 11-8. Japan responded through Nakata and Ishida, yet Bahrain maintained control through further strikes from Habib and Jassim Khamis. Behind them,

goalkeeper Mohammed Abdulhussain was outstanding, making seven first-half saves to help secure a 17-14 advantage at the break, even as Japan threatened with their well-known ability to mount comebacks.

The second half belonged entirely to Robert Hedin's side. Khamis struck early, while Al Sayyad grew increasingly influential, throwing himself into defensive blocks and urging his teammates on. Abdulhussain produced a succession of spectacular saves, including one that struck him in the face mid-play, yet he continued unfazed, visibly frustrating the Japanese attack. Bahrain steadily pulled away as Habib, Khamis, Hassan Madan, Qassim Qamber, Mohamed Rabeea, and Ahmed

Kadhem stretched the margin to double digits midway through the half.

Habib Nasser led the scoring with nine goals, Khamis added seven, and Madan chipped in with three, while Abdulhussain's 16 saves deservedly earned him the man-of-the-match honours.

Bahrain will now face defending champions Qatar in tomorrow's final at 6pm after the Qataris edged hosts Kuwait in a pulsating extra-time semi-final. Japan, meanwhile, will contest the bronze-medal match against Kuwait at 4pm, bringing the championship to an exciting conclusion. All matches are taking place at Sheikh Saad Al-Abdullah Al-Salim Al-Sabah Covered Halls.

Alcaraz sweeps into maiden Melbourne semi as Gauff gone in 59 minutes

Carlos Alcaraz warned he was improving all the time as he swept into his maiden Australian Open semi-final yesterday and a clash with Alexander Zverev, while Ukraine's Elina Svitolina faces Aryna Sabalenka in the last four.

Spanish world number one Alcaraz silenced a partisan Melbourne crowd in brushing aside home hope Alex de Minaur 7-5, 6-2, 6-1 at Rod Laver Arena.

The 22-year-old Alcaraz is yet to drop a set as he arrows in on a first Australian Open crown.

"I'm just really happy how I'm playing every match, each round my level is increasing," he said, in a warning to his rivals.

"Today I felt really comfortable, playing great tennis that I am really proud of," added Alcaraz, who had never previously gone beyond the quarter-finals in Australia in four previous

visits.

The Australian Open is the only Grand Slam that Alcaraz has not won.

Should he beat Zverev and then win Sunday's final, he would surpass compatriot and legend Rafael Nadal as the youngest man to win all four majors.

Nadal was 24 when he did it.

In a statement of his own, Zverev said he was playing without pain for the first time in 12 months after last year's runner-up blasted past young American Learner Tien.

Zverev sent down 24 aces in a 6-3, 6-7 (5/7), 6-1, 7-6 (7/3) victory.

World number three Zverev is desperate to finally win a Grand Slam at age 28, having lost three major finals including being well beaten in last year's title decider by Jannik Sinner.

The German's 2025 season fell away after that, winning just one title in an injury-hit campaign and he also struggled with his mental health, taking a one-month break after losing in the first round at Wimbledon.

"The last 10 days I felt healthy,

which is very nice, and pain-free, which I haven't felt in a long time. Probably in 12 months," he said after dismantling Tien.

Gauff's epic racquet smash

Coco Gauff folded in 59 error-strewn minutes as Svitolina set up a semi-final against Sabalenka.

Belarusian world number one Sabalenka tamed 18-year-old American Iva Jovic 6-3, 6-0 in 38C temperatures on Rod Laver Arena.

heat, 12th seed Svitolina stunned third seed Gauff 6-1, 6-2.

Television images showed Gauff repeatedly smashing her racquet in the bowels of the stadium afterwards.

The Ukrainian, who is on a 10-match win streak after a title-winning run at Auckland this month, added: "It means the world to me."

Svitolina said she hopes her stunning upset will bring "a little light" to her fellow Ukrainians during a bitter winter under attack by Russia.

For two-time Grand Slam winner Gauff, a decade younger at 21, it was more Melbourne misery.

She has still never gone beyond the semi-finals and the nature of the loss will sting.

Gauff's serve deserted her, broken four times in the first set and twice in the second to leave her title aspirations in tatters.

She was not amused to learn that her epic racquet smash was caught by television cameras.

"I tried to go somewhere where they wouldn't broadcast it, but obviously they did," she said.

"So maybe some conversations can be had because I feel like at this tournament the only private place we have is the locker room."

In the first action of the day, Sabalenka closed in on a third Melbourne crown in just four years.

Having been stunned in last year's final by the American Madison Keys, the hard-hitting Belarusian said it was "trophy or nothing" after muscling past the supremely talented Jovic.

The quarter-finals conclude on Wednesday, with 10-time Melbourne champion Novak Djokovic and title-holder Jannik Sinner in action.

Djokovic faces Italian fifth seed Lorenzo Musetti and Sinner plays Ben Shelton of the United States.

In the women's draw, Jessica Pegula and Amanda Anisimova meet in an all-American affair and second seed Iga Swiatek faces fifth seed Elena Rybakina.

Temperatures are scheduled to be considerably cooler.

Guardiola blames Man City team for Haaland struggles
