‘Enjoy your holidays’, Tsitsipas tells Kyrgios after United Cup pullout

Greek tennis star Stefanos Tsitsipas yesterday told rival Nick Kyrgios to “enjoy his holidays”, after the Australian stunned his team by withdrawing from the United Cup at the last minute.

Kyrgios pulled out of the mixed teams event on the eve of the inaugural tournament, to be held in Sydney, Brisbane and Perth.

“It is not a surprise, I hope he enjoys his holidays,” Tsitsipas, the main talent on the eight-player Greek side in Perth, said.

The pair have had a fractious relationship which came to a head at Wimbledon this year when Tsitsipas said his Australian opponent had an “evil side”, after a bad-tempered third-round match.

That contest descended into mayhem when a frustrated Tsitsipas hit the ball into the crowd after losing the second set and Kyrgios told the um-

pire his opponent should be kicked out of the tournament.

The bad feeling bubbled up again in post-match press conferences, with Tsitsipas calling him “a bully”.

Kiwi centurions Williamson and Latham punish fumbling Pakistan

Kane Williamson and Tom Latham hit contrasting hundreds yesterday to propel New Zealand to 440-6 at the close on the third day of the first Test against Pakistan in Karachi.

Williamson survived two stumpings and a leg-before decision before knocking an unbeaten 105, while Ish Sodhi was on one, with the tourists leading by two runs.

Williamson’s 25th Test century is his first in international cricket since he racked up 238, also against Pakistan, in Christchurch in January last year.

He built on a solid foundation laid down by openers Latham, who cracked 113 en route to his 13th Test century, and Devon Conway, who fell for 92.

With the National Stadium pitch likely to take spin on the last two days, New Zealand will look to press home their advantage in the first Test of the two-match series, their first in Pakistan since 2002.

Williamson pushed fast bowler Mohammad Wasim for a sharp single to complete his hundred, a fifth against Pakistan.

In all he has batted for 356

minutes, cracking 11 boundaries. But Pakistan were left ruing missed chances as wicketkeeper

Sarfraz Ahmed fumbled two stumpings with Williamson on 15 and 21 -- spinner Nauman Ali the unlucky bowler on both occasions.

“I think they were chances but one of the deliveries was on the leg side and Sarfraz did his best,” said Nauman.

“This pitch is on the slow side so our effort will be to get the last four wickets early on day four and then set a good target of close to 200 -- which will be good on this pitch.”

Williamson added a solid 90 for the fifth wicket with Tom Blundell, who fell to Wasim after scoring 47.

Pakistan’s spin duo of Nauman and Abrar Ahmed took two wickets in the post-lunch session, with Henry Nicholls falling for 22 and Daryl Mitchell scoring a robust 47-ball 42.

Ahmed, who has figures of 3-143, also had Michael Bracewell for five.

Williamson, who also over-turned a leg-before decision against him on 13, added 65 for the fourth wicket with Mitchell.

Mitchell smashed seven boundaries and a six including four consecutive fours off Wasim after Pakistan took the second new ball at 272-3.

Pandya to captain India in T20I series against Sri Lanka

Hardik Pandya will captain India for their Twenty20 series against Sri Lanka next month in the absence of Rohit Sharma, who will return for the following one-day internationals, the Board of Control for Cricket in India (BCCI) said on Tuesday.

India will host Sri Lanka for three T20Is and three ODIs from Jan. 3, with Pandya reprising his role as T20 captain for a second straight series, after leading India to victory over New Zealand
