Shura Council to review unified GCC road transport law for fairness and safety

Shura Council members will consider on Sunday a report urging approval of Decree-Law No. 35 of 2025, which adopts a unified GCC framework for international road transport.

The Foreign Affairs, Defence and National Security Committee said it reviewed the lower chamber's decision and its papers, alongside the view of the Shura Council's Legislative and Legal Affairs Committee, which found the decree-law sound in constitutional and legal terms.

The committee also examined a separate legal opinion memorandum and discussed the text with two legal advisers before recommending approval.

Bahrain needs to upgrade its procedures in line with the GCC-wide rules to protect Bahraini carriers and ensure equal terms, while also supporting trade and raising road safety.

Delay

In its reasoning, the committee pointed to a delay in bringing the GCC framework into force after the planned start date had already passed.

It said the delay risked leaving a gap in the rules that could disrupt cross-border road transport, particularly as Saudi Arabia has already begun applying the unified provisions.

The committee said Bahrain needed to bring its procedures into line to protect Bahraini carriers and ensure equal terms, while also supporting trade and raising road safety through shared technical rules and stricter controls on vehicles and transport operations.

The decree-law has six articles.

Regulation

It approves the attached unified regulation, defines the 'competent authority' as the body to



be designated by decree, and, for the purposes of applying the regulation, sets the rate at one Bahraini dinar to ten riyals.

It also sets out how appeals can be made against decisions issued under the regulation, its executive rules and related decisions, keeps existing decisions in force until the executive rules are issued, and includes an implementing article.

The attached regulation contains 25 articles. It opens with definitions, aims and scope.

It then deals with operating cards and covers return trips, entry without a load, transport by unregistered vehicles, and domestic transport of passengers and goods.

Requirements

It also sets technical requirements for vehicles, rules on carrying goods and on exceptional loads, and duties placed on carriers and drivers, including limits on how long a vehicle may remain within a member state and rules on weights and dimensions.

Later articles deal with violations and administrative penalties, repeat offences and how fines are paid.

The final provisions cover appeals, fees and taxes, judicial enforcement powers, and the mechanism for issuing the executive rules.

The committee also explained why the measure was issued as a decree-law under Article 38 of the Constitution.

Recess

It said it was issued on 19 August 2025 during the recess, after the close of the third session of the sixth legislative term and before the start of the fourth session, and was submitted to both the Shura Council and the Council of Representatives on 24 August 2025 for review.

It said the conditions in Article 38 were met, including the need for urgent action, and that the decree-law satisfied the required legal and procedural tests.

Kani shawls worth BD1,150 at Autumn Fair

One of the standout highlights of the Autumn Fair was a rare hand-embroidered Kashmiri shawl, valued at over BD1,000, which can take up to two years to complete.

Veteran exhibitor Mohammed Rafeal, who has participated in the fair for 22 years, said some exclusive pieces reach BD1,150, reflecting the skill, patience, and heritage behind each creation.

Rafeal stressed that true craftsmanship remains unmatched, saying every shawl is entirely handcrafted, from spinning the wool to the final Sozoni embroidery.

He explained that some rare Kani shawls are woven using wooden needles, with pashmi-

na wool sourced from Ladakh, a region known for extreme sub-zero temperatures.

"This wool is a gift of nature," he said.

Long-time customer Um Ali, who has been purchasing Kashmiri shawls for more than 15 years, shared her appreciation for the craftsmanship.

She said the pieces are timeless investments, often passed down through generations, adding that quality and heritage matter more than price.

Beyond Kashmiri craftsmanship, the Autumn Fair also showcased strong international participation. Vendors from India, Syria, Oman, Yemen, and Africa praised the fair's organisation and visitor turnout, with many confirming their intention to return next year.

First-time African exhibitors

reported high demand for natural shea butter from Guinea, alongside traditional baskets and skincare products, while Omani and Yemeni participants highlighted the impact of local marketing and the welcoming nature of the Bahraini public.

Woman cleared of trafficking

A woman has been acquitted of human trafficking after the High Criminal Court quashed a three-year jail term handed down in her absence, saying the case file did not show she was responsible for paying a domestic worker's wages or for bringing her to Bahrain.

The court said it was not satisfied the charge was properly attributed to her and found the elements of the offence were not made out.

In its reasoning, it said the complaint was filed by the Labour Market Regulatory Authority against the woman's husband as the employer responsible for paying the worker.

It also cited documents showing the husband filed a report with the police directorate stating the maid had absconded.

Statement

The judgment said the defence produced a written statement from the worker's husband confirming he alone was responsible for all of her entitlements and monthly wages, and that the accused

had no role in paying her.

He also said he recruited the worker and brought her from her country under his sponsorship, adding that his wife had no involvement and was not required to pay the worker's wages. With nothing in the case file showing the accused was obliged to pay the worker, the court said the charge could not stand. It added that it found no indication of human trafficking on the facts, and it therefore overturned the in-absentia verdict and acquitted her under Article 255 of the Criminal Procedure Code.

Her lawyer, Zahra Hussain, had earlier asked for an acquittal, saying her client denied the allegation and had no legal or factual connection to the worker. She argued the woman was not the sponsor, not the employer, and was not involved in recruiting the worker or entering into any agreement to employ her.

Hussain told the court the case file contained no document linking the accused to the worker through sponsorship, an employment contract or any other legal relationship that would make her responsible for the worker's presence in the country or for managing her affairs.

Shura Council to debate Disability Law changes

The Shura Council will debate on Sunday a decree-law that updates the governance and terminology of the committee responsible for disability affairs, after its Services Committee said the amendments meet constitutional and legal requirements and do not affect existing rights or benefits.

The Services Committee said it examined the decree-law following extended discussions among members and the committee's legal adviser, and after reviewing an opinion from the Shura Council's Legislative and Legal Affairs Committee, which confirmed its constitutional and legal soundness.

It also said it reviewed the decision of the Council of Representatives and the documents attached to it.

In explaining its view, the committee said the changes are intended to keep the legislation in step with modern rights-based standards, reinforce the dignity and rights of persons with disabilities, and

update the legal framework to match national policies and the government programme aimed at empowerment and inclusion.

A central amendment changes how the relevant committee is defined in law.

The title 'Higher Committee' is removed and replaced with a reference to the committee established under Article 16, with its name, composition and term of membership to be set by a decision issued by the Prime Minister.

The Services Committee said this approach allows future administrative adjustments without repeated amendments to the law.

It added that the updated naming also follows the state's direction towards using inclusive language that emphasises capability, participation and full inclusion in society, rather than language centred solely on care. The Services Committee said the amendments are limited to organisational and co-ordinating matters, including titles and the committee's arrangements, and do not alter the substantive provisions of the 2006 law.

Family refusal

Couple charged after leaving disabled son in hospital for 10 years

The Head of the Family and Child Prosecution said that the Public Prosecution received a complaint from government hospitals after the parents of a patient with disabilities refused to take him home after his treatment was completed.

According to the complaint, the patient, who has a mild intellectual disability, was admitted to a government hospital in 2015 due to an immune disease. All necessary medical tests and treatment were completed within two weeks of his admission.

However, his parents repeatedly refused to take their son home, despite many attempts by hospital staff to convince them of their responsibility to care for him.

Refusal

As a result, the patient remained in the government hospital for more than ten years due to his parents' continued refusal to receive him because of his intellectual disability.

The Public Prosecution immediately started an investigation and heard the testimony of the Deputy Head of the Long-

Stay Committee at government hospitals.

She confirmed that the patient's health condition does not require hospital admission and that several meetings were held with both parents to persuade them to take their son, but without success.

Danger

She added that the son is in his forties, that his intellectual disability makes his thinking similar to that of a ten-year-old child, and that he does not pose any danger to his family or to society.

Investigations also showed



that the son has been registered with the Ministry of Social Development as a person with disabilities since 2005, and that his parents have been receiving his disability allowance since that time.

The parents were questioned and clearly refused to take their son, claiming they were unable to care for him.

Findings

Based on these findings, the Public Prosecution ordered that the parents be referred to trial on charges of neglecting their legal duty to care for their son with disabilities, an offense punishable by imprisonment

and a fine under Law No. (74) of 2006 on the care, rehabilitation, and employment of persons with disabilities.

The Head of the Prosecution stressed that while the state is committed to protecting the rights of all members of society, parents and legal guardians also have a legal and moral responsibility to care for those under their care.

She noted that the parents' refusal to take their son from the hospital for more than ten years represents a serious breach of this responsibility, especially as they continued to receive his disability allowance during that period.

Draft law on International Date Observatory HQ set for review

The Shura Council will debate on Sunday a draft law approving an agreement between Bahrain and the International Date Council to establish the headquarters of the International Date Observatory in Bahrain, accompanying Decree No. 64 of 2025.

The agreement was signed in Manama on 22 September 2025 and would need to be enacted as a law to take effect in Bahrain, under Article 37 of the Constitution.

The bill is brief, consisting of a preamble and two articles. The first approves the agreement, while the second covers implementation.

Under the agreement, the Observatory's permanent headquarters would be in Bahrain.

Powers

It would have legal personality and the power to enter into contracts, and to acquire, own and dispose of movable and immovable property, provided this does not conflict with Bahraini law.

The report said Bahrain would grant the facilities needed for the Observatory to carry out its work, which focuses on collecting, analysing and publishing data on the global dates market to support decision-making by the International Date Council's member states.

The agreement also allows the Observatory, within its remit and in line with Bahraini law,

to hold funds, open accounts in different currencies, and bring in money, securities and foreign currency or transfer them abroad in line with applicable rules.

Recommendations

The committee said the Observatory would be required to have regard to any observations and recommendations

made by the Bahraini government when exercising those rights.

It said the Director of the International Date Council would submit to Bahrain's Ministry of Foreign Affairs a list of the names and addresses of the Observatory's director and staff, and would notify the ministry of any changes.

The report said the agreement would not affect Bahrain's right to take steps to protect security, safety and public order in emergency or exceptional circumstances.

Correspondence

It also requires the Observatory's correspondence with government bodies in Bahrain to go through the Observatory's director via the Ministry of Foreign Affairs.

The committee said the remaining provisions set out an amicable settlement process for disputes over the agreement's application or interpretation, as well as rules for amendment, entry into force, duration and termination, and the number of copies and the language of the text.

Eight convicted over work permits linked to fake companies

The Public Prosecutor, head of the Ministries and Public Authorities Prosecution, said that criminal courts issued three rulings convicting eight people.

They had obtained work permits linked to fake companies and kept them without any real need.

In the first case, five people were sentenced to one year in prison and deported permanently. They had obtained 93

work permits linked to 51 fake company records without needing them.

In the second case, one person was fined 61,000 dinars and permanently deported. This person had taken 61 work permits linked to 32 fake company

records without needing them.

In the third case, one person was fined 40,000 dinars and another person was fined 2,000 dinars, and both were deported permanently. They had obtained 42 work permits linked to 21 fake company records.

The moment visitors step into the Turkish section at the 2026 Autumn Fair, the atmosphere shifts.

The sounds, scents, colours and even the attire of the vendors combine to create the feeling of walking through a lively street in Turkey, offering an experience that goes far beyond conventional shopping.

From the first steps, the aroma of freshly prepared Turkish food fills the air.

Traditional baklava, rich chocolates, creamy ice cream (dondurma) and familiar drinks such as ayran welcome visitors, alongside cups of au-

Confectionery

What stands out most is the presence of well-known Turkish confectionery brands that are popular among Bahrainis.

Health tourism visa and new supervising committee included in Shura draft law

Invoices, upfront quotes and a health tourism visa would be introduced for medical visitors under a Shura Council draft law that also creates a national committee to coordinate the sector and increases what hospitals must tell patients before they fly in.

The proposal, put forward by Shura members Dr Jameela Al Salman, Dr Jehad Al Fadhel, Dalal Al Zayed, Dr Ebtesam Al Dallal and Ali Al Aradi, would require health providers to publish and stick to declared prices, give patients itemised bills, and submit periodic reports to the National Health Regulatory Authority (NHRA), which would oversee compliance.

Health establishments seeking to agree treatment with a pa-

tient before arrival would have to send a written invitation explaining an estimated diagnosis and the documents relied upon, the proposed course of treatment, major risks linked to the treatment because of its nature or the patient's circumstances, and an assessment of expected outcomes.

Quote

The invitation would also need to include a detailed price

quote for the proposed treatment, alongside an approximate estimate for extra treatments outside the original plan that may be needed.

The draft defines a health tourism visa as an entry permit allowing individuals to enter Bahrain to receive health services.

It defines the service recipient as any person who enters the kingdom for that purpose.

Services

Health tourism services are described in wide terms, covering examination, diagnosis and treatment, as well as nursing, healthcare, dietary programmes, accommodation and convalescence.

The definition also covers related support such as first aid, medicines, lab work and radiology tests, and allows the Supreme Council of Health to specify other similar services by decision.

Alongside the pre-arrival invitation requirement, the draft would place duties on health establishments providing health tourism services.

MPs call for 24-hour cancer emergency wing at hospital

diotherapy, leaving them exposed to serious, potentially life-threatening complications if urgent care is delayed.

They describe King Hamad University Hospital as a key referral centre for cancer care in Bahrain, and say a dedicated emergency wing would improve the quality of care, reduce infection rates and provide a safer setting for patients with low immunity.

The document also says the move would ease pressure on general A&E services by directing sensitive cases to a specialised unit, with added privacy and greater efficiency, in line with efforts to improve health services and quality of life.

The proposal was submitted by MPs Mohammed Al Rifai and Mohammed Mousa, along with Abdulwahid Qarata, Ali Saqer Al Doseri and Hisham Al Awadhi.

A group of MPs have filed an urgent proposal calling for a dedicated emergency wing for oncology patients at King Hamad University Hospital, operating 24 hours a day.

The proposal asks for a separate unit reserved for cancer patients, staffed by specialist doctors and nurses, and fitted with isolation rooms for those whose immune systems are weakened after chemotherapy.

Its backers say the aim is to ensure faster handling of emergencies and cut health risks linked to delays in treatment or the spread of infection.

Memorandum

In the accompanying memorandum, they argue that oncology patients can suffer severe immune suppression after chemotherapy and ra-

News in brief

China executes 11 linked to Myanmar scam compounds



China executed 11 people linked to Myanmar criminal gangs, including “key members” involved in telecom scam operations, state media reported. Fraud compounds have flourished in Myanmar’s lawless borderlands, part of a multibillion-dollar illicit industry. The centres are typically staffed by foreigners – including many Chinese – with many saying they were trafficked and forced to swindle people online. Beijing has stepped up cooperation with South-east Asian nations in recent years to crack down on the compounds, and thousands of people have been repatriated to China.

Denmark’s foreign minister said yesterday he was “more optimistic” after technical talks kicked off with the United States over Greenland. “We have had the very first meeting at senior official level in Washington yesterday regarding the Greenlandic issue,” Lars Lokke Rasmussen told journalists at an EU meeting in Brussels. “It went well in a very constructive atmosphere and tone, and new meetings are planned. It’s not that things are solved, but it’s good.” The trilateral talks come after US President Donald Trump last week backed down from his threats to seize the autonomous Arctic territory of EU and NATO member Denmark.



Bodies pulled from sea as Philippine ferry toll rises to 29



Eleven more bodies were pulled from waters off the southern Philippines yesterday, the coast guard said, days after a ferry capsized and threw hundreds of people into the sea. The discovery brought the confirmed death toll to 29, officials said in a statement, three days after the MV Trisha Kerstin 3 went down off southwestern Mindanao in the early hours of Monday. The ferry was carrying at least 344 passengers and crew, most of whom were rescued in the immediate aftermath.

‘I am a knight’: Paris’ last newspaper hawker gets top French award

Ali Akbar Akbar has been homeless, experienced extreme poverty and had been attacked.

On Wednesday, President Emmanuel Macron made Pakistan-born Akbar, believed to be the last newspaper hawker in Paris, a knight in the national order of merit in recognition of his service to France.

The French president praised Akbar’s “incredible destiny”, thanking the septuagenarian for arriving from Pakistan decades ago, selling newspapers for 50 years and carrying France in his heart.

“Dear Ali, thank you for bringing political news to our terraces at the top of your lungs, for warming the hearts of the Flore, the Deux Magots, the Lipp brasserie,” Macron said in his speech at the Elysee Palace, referring to some of the French capital’s iconic cafes.

“You are the accent of the 6th arrondissement. The voice of the French press,” Macron

told Akbar, who was surrounded by his family.

Akbar, who is known for inventing sensational headlines, sells his wares round the upmarket streets of Saint-Germain-des-Pres where he has become a neighbourhood legend.

French has “become your language”, Macron told the slim, sharply dressed man. “You have learned to play with it, making it your own.”

“You have carried, if I may say so, the world in your arms and France in your heart,” Macron added.

He praised Akbar as an example of integration which “makes our country stronger and prouder.”

“He is a magnificent example at a time when we so often hear bad news,” Macron said.

“There are also many stories like Ali’s, of women and men who fled poverty to choose a country of freedom.”

Akbar said he was “deeply moved” and already knew what he would shout on the streets of Paris in the coming days.

Starmer hails progress in China

Visit marks thaw in ties as Starmer, Xi discuss trade, migration, and global stability

- Visa-free travel agreed for Britons
- Trade, health and security deals signed
- China calls for “restart” of UK–China golden era

Britain’s Prime Minister Keir Starmer hailed “really good progress” on issues including visa-free travel and tariffs during talks with Chinese leader Xi Jinping in Beijing yesterday.

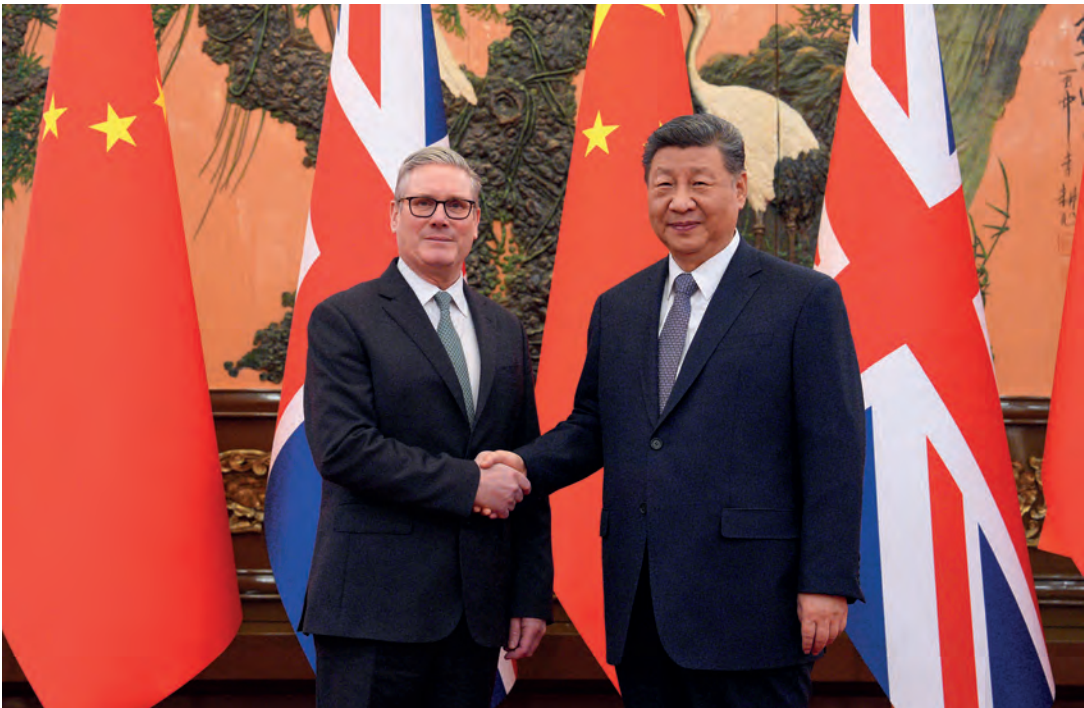
Starmer’s visit to China is the first by a British premier since 2018 and follows a slew of Western leaders seeking a rapprochement with Beijing recently, pivoting from an increasingly unpredictable United States.

Xi and Starmer met at the opulent Great Hall of the People and both stressed the need for closer relations in order to face geopolitical headwinds.

Starmer told Xi that China is a “vital player on the global stage” and that they needed to “build a more sophisticated relationship where we identify opportunities to collaborate”.

The Chinese leader also stressed the need for stronger ties with a “long-term view” in the context of what he called a “complex” international situation.

Cooperation, he said, would unlock a “new chapter” in their relations.

Starmer, who is in China until Saturday, later told reporters that the bilateral relationship was in “a strong place”, with progress made on issues such as whisky tariffs.

He signed a series of cooperation agreements after meeting Premier Li Qiang, with Downing Street announcing Beijing had agreed to visa-free travel for British passport holders visiting China for under 30 days.

That brings Britain in line with about 50 other countries allowed visa-free access, including France, Germany, Australia and Japan, and follows a similar agreement made between China and Canada this month.

The agreements also included cooperation on targeting

supply chains used by migrant smugglers, as well as on British exports to China, health and strengthening a UK-China trade

commission.

The issue of irregular migrants is highly sensitive for Starmer, who has promised to crack down on people smugglers and stem a wave of arrivals that has fuelled rising support for the far right.

Li hinted that “China and the UK can restart their golden era”, enjoyed by the two countries a decade ago.

“China and the UK have successively resumed dialogue and exchanges in multiple fields... This fully demonstrates that China and the UK are adhering to development and cooperation,” Li told Starmer.

The British leader in turn reiterated his commitment to “find ways to work together in a manner which is fit for these times”.

US border chief says not ‘surrendering’ immigration mission

President Donald Trump’s border chief vowed yesterday to press on with the federal immigration crackdown in Minneapolis while acknowledging the mission needed to improve and promising to hold agents to account.

“We’re going to make sure we do targeted enforcement operations,” Tom Homan told reporters in the Minnesota city. “We are not surrendering our mission at all. We’re just doing it smarter.”

“President Trump wants this fixed. And I’m going to fix it.”

The border czar called on Minnesota’s residents to turn down the temperature and stop what he called “hateful rhetoric” against federal agents carrying out immigration raids.

Minneapolis has been gripped by weeks of protests against the roundup of undocumented migrants. Two Americans demonstrating against the sweeps have been shot dead by federal agents.

Homan struck a conciliatory tone at his first press conference, a marked difference from the Border Patrol commander who was previously heading the mission on the ground and has since been removed.

“One thing everybody I talked to agreed on was that communi-

ty safety is paramount,” Homan said.

“The mission is going to improve because of the changes we’re making internally,” he said. “President Trump and I, along with others in the administration, have recognized that certain improvements could and should be made.”

“That’s exactly what I’m doing here,” he said.

Homan said any federal agents

who breach codes of conduct “will be dealt with.”

The two agents involved in the latest shooting -- that of 37-year-old Veterans Hospital nurse Alex Pretti -- have been placed on leave pending an investigation.

Trump has scrambled to stem outrage across the political aisle over the killing, saying Tuesday he wanted to “de-escalate a little bit” in Minneapolis.

But the president on Wednesday

accused the city’s mayor Jacob Frey of “PLAYING WITH FIRE” for refusing to rally local police to enforce the federal immigration sweeps.

The political battle could soon move to Congress, where Democrats are threatening to hold up authorization for swathes of government funding if reforms are not made to rein in the sprawling military-style immigration agencies.



Iran vows ‘crushing response’, EU targets Revolutionary Guards

Tehran threatens retaliation as Trump issues a nuclear deadline and the EU acts

● Turkey offers to mediate between US and Iran

Iran yesterday vowed a “crushing response” to any attack after US President Donald Trump warned time was running out for a nuclear deal, and as the European Union looked to declare the Revolutionary Guards a terrorist organisation.

Foes Washington and Tehran have exchanged sharp warnings since a protest wave in Iran led Trump to threaten military action over a violent crackdown, while the Islamic republic blamed the United States for fuelling what it deemed “riots”.

The face-off has sent diplomatic shock waves across the region, with calls for negotiations to defuse tensions drawing in key regional actors.

The EU is expected yesterday to agree to put Iran’s Revolutionary Guards (IRGC) on the bloc’s “terrorist list” over the crackdown, which rights groups say saw thousands killed by security forces, including the IRGC -- the ideological arm of Tehran’s military.

“If you act as a terrorist, you should also be treated as terrorists,” top diplomat Kaja Kallas told journalists ahead of a ministers’ meeting in Brussels, adding that the step puts the Guards on the same level as jihadist groups such as Al-Qaeda and the Islamic State group.

The symbolic move will send a strong message of condemnation to Iran, though it is expected

to have little practical impact, as the organisation and senior commanders are already under EU sanctions. The bloc yesterday added another 15 Iranian officials and six entities to its asset freeze and visa ban blacklist.

However, Iran has warned of “destructive consequences” if the designation is greenlit, state media reported Tuesday.

‘Potential for negotiations’

Iranian officials have also ratcheted up warnings that Tehran would respond forcefully to any US military action, while not ruling out diplomatic solutions.

Iran’s army chief Amir Hatami yesterday vowed a “crushing response” to any attack, according to state television, which reported 1,000 “strategic drones” had

joined the combat regiments.

A US naval strike group arrived in Middle East waters on Monday, with Trump warning it was “ready, willing and able” to hit Iran “if necessary”.

He said Wednesday that “time is running out” for Iran to negotiate a deal over its nuclear programme, which the West believes is aimed at making an atomic bomb.

The United States had hit Iranian nuclear targets when it briefly joined Israel’s war against Iran in June.

Iran’s neighbours, including Gulf states that host US military sites, have called for calm.

A Gulf official told AFP that fears of a US strike on Iran are “very clear”.

“It would bring the region into chaos, it would hurt the economy

not just in the region but in the US and cause oil and gas prices to skyrocket,” the official added.

Turkey yesterday said it would offer to mediate between Washington and Tehran during an upcoming visit by Iranian Foreign Minister Abbas Araghchi, after Ankara’s top diplomat urged Washington to start nuclear talks with Tehran.

“It’s wrong to attack Iran. It’s wrong to start the war again. Iran is ready to negotiate on the nuclear file again,” Turkish Foreign Minister Hakan Fidan told Qatar-based Al-Jazeera television in English.

NATO member Turkey is also weighing contingency plans along its 530-kilometre (330-mile) border with Iran should the dispute escalate, a senior official told AFP.



EU foreign policy chief Kaja Kallas said the move to blacklist the IRGC “puts them on the same level as Al-Qaeda and ISIS” – a sharp symbolic rebuke of Tehran’s actions

Iran ally Russia yesterday also said “the potential for negotiations is not exhausted”.

“Any use of force can only create chaos in the region and lead to very dangerous consequences,” Kremlin spokesman Dmitry Peskov told journalists.

Egyptian Foreign Minister Badr Abdelatty in a call with his French counterpart Jean-Noel Barrot stressed the need for “the resumption of dialogue between the United States and Iran regarding the Iranian nuclear file”, Cairo said.

Trump’s recent statements have focused more on Iran’s nuclear programme than the fate of protesters in the anti-government demonstrations that erupted in late December and peaked on January 8 and 9.

In an updated toll, the US-based Human Rights Activists News Agency (HRANA) said it had confirmed that 6,373 people had been killed and more than 40,000 arrested, as internet restrictions persisted after a shutdown imposed on January 8.

Heavy security near Niger capital’s airport after gunfire, blasts

Security forces were deployed around the international airport in Niger’s capital yesterday after heavy gunfire and explosions erupted overnight in what several observers said bore the hallmark of a jihadist attack.

Niger, a Sahelian country regularly hit by jihadist violence, has been led for more than two years by Abdourahamane Tiani, the head of a junta that over-

threw the elected civilian president in 2023.

The shooting began shortly after midnight, according to residents of a neighbourhood near the airport in Niamey.

Calm returned two hours later, they said.

Videos filmed by local people showed streaks of light in the sky with the sound of loud explosions, while other images showed flames several metres high and charred cars.

EU eyes migration clampdown with push on deportations, visas

The European Union yesterday laid out plans to overhaul its visa system and step up deportations as part of a five-year migration strategy that cements a hardening line on the hot-button issue.

Irregular arrivals in the 27-nation bloc were down by more than a quarter in 2025, according to the EU’s border agency -- but political pressure to act remains high.

“The priority is clear: bringing illegal arrival numbers down and keeping them down,” Magnus Brunner, the EU’s commissioner for migration, said.

The strategy unveiled yesterday stressed the need to boost deportations of failed asylum-seekers among the bloc’s priorities.

“Abuse gives migration a bad name -- it undermines public

trust and ultimately takes away from our ability to provide protection and undercuts our drive to attract talent,” said Brunner.

The European Parliament is currently examining a legal text put forward by the European Commission allowing for so-

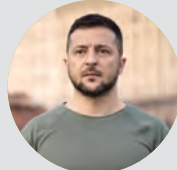
called “return hubs” to be set up outside the EU’s borders.

Criticised by rights groups, the proposal also envisages harsher penalties for migrants who refuse to leave European territory, including longer periods of detention.

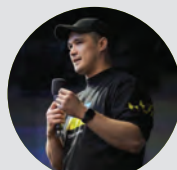

Interior Minister Receives New US Ambassador



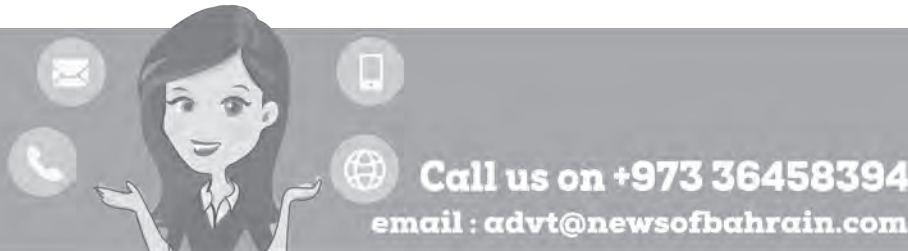

Bahrain's Warriors Conquer Asia



Captain AlSaiyyad Lifts the 22nd Asian Handball Championship for Bahrain

In a moment destined to live forever in Bahraini sport, the national men's handball team captured their first-ever Asian Championship, defeating defending champions Qatar 29–26 in extra time in Kuwait City. After years of dedication and ambition, this generation etched their names into the nation's sporting history with a performance of rare quality. Head coach Robert Hedin, whose impact since his appointment in 2025 has been transformative, guided the team masterfully throughout the tournament. His players entered the final with

confidence, having lost only one game up till this point and already defeated Qatar in the preliminary round. Yesterday's final began at a blistering pace. Captain Hussain AlSaiyyad opened the scoring at 01:34, quickly matched by Qatar's Rafael Capote. AlSaiyyad struck again at 02:46, followed by Jasim Khamis at 03:33. Qatar's Ahmad Madadi and Ahmed Kadhem kept the game close, but AlSaiyyad, ever the leader, scored once more at 08:16. Mohammed Habib Nasser, the tournament's Best Playmaker, then exploited a gap with a precise feed from Ali AlAsheeri, firing past the keeper to give Bahrain a 14–11 halftime lead. Goalkeeper

Mohammed Abdulhussain, a fortress throughout the campaign, frustrated the Qataris with crucial saves, stopping 13 of 39 shots. The second half saw Danijel Saric's side rally. Wael Mzoughi scored early to narrow the gap, and Madadi's goal leveled the score at 13–13. AlShowaikh responded at 05:40, Khamis at 06:56, keeping Bahrain ahead. Both sides traded goals over the next 20 minutes, with Hasan Madan and AlSaiyyad contributing important strikes. Abdulhussain repeatedly denied fast breaks and seven-metre attempts, while Qatar's men kept the contest tight, and sent the match into extra time at 24–24.

The extra period was a tense spectacle. Salman AlShowaikh broke through from the wing, assisted by AlSaiyyad, to put Bahrain ahead 25–24. In the eighth minute, Bahrain led 26–24 when Abdulhussain produced another seven-metre save. Moments later, a fast break following Abdulrazzaq Murad's two-minute suspension extended Bahrain's lead. As celebrations began, AlShowaikh converted a flawless seven-metre throw, and Madan bullied his way past Qatar's defense to make it 28–25. Abdulhussain denied another seven-metre attempt at 29–25, prompting a joyous eruption from his teammates as the win became inevitable.

Bahrain held on to secure a 29–26 victory, with AlSaiyyad visibly emotional at the final whistle as he celebrated with the traveling fans. Earlier in the day, hosts Kuwait claimed the bronze medal after a 33–32 win over Japan, but it was Bahrain who stole the show. The title-win reflected both collective effort and individual brilliance: Hussain AlSaiyyad and Mohammed Habib Nasser each scored 7 apiece, Jassim Khamis 6, and Salman AlShowaikh 6. With this historic win, Bahrain now turns its focus to the 2027 World Championship in Germany, joining Qatar, Kuwait, and Japan among Asia's handball elite.

No handshake as Sabalenka sets up repeat of 2023 Melbourne final

Belarusian world number one Aryna Sabalenka crushed Ukraine's Elina Svitolina in a politically charged Australian Open semi-final yesterday and faces Elena Rybakina for a third Melbourne title. There was no handshake after Sabalenka dismantled Svitolina 6–2, 6–3, before Kazakhstan's Rybakina was also a straight-sets winner, over Jessica Pegula of the United States. The ruthless Sabalenka will take some stopping as she pursues a third Melbourne crown in four years. She is on an 11-match win

streak this year, having come into the first major of 2026 on the back of claiming the title in Brisbane. The hard-hitting 27-year-

old is into her fourth Australian Open final in a row and yet to drop a set all year. Sabalenka and Moscow-born fifth seed Rybakina have met

14 times, with the Belarusian winning eight of them. That includes the Melbourne final in 2023, when Sabalenka fought back to win in three sets. Ahead of her semi-final clash with 12th seed Svitolina, an announcement was made at Rod Laver Arena that there would be no handshake afterwards, asking fans to "respect" that. Like other players from Ukraine, Svitolina does not shake hands with opponents from Russia or Moscow's ally Belarus because of the war. Sabalenka and Svitolina also noticeably kept apart for the pre-match formalities and photos.

After a dominant victory, Sabalenka was close to tears as she reflected on the "dream" life she leads. She had warm words for Svitolina, saying: "I'm super happy with the win, she's a really tough opponent, she was playing really incredible tennis throughout the whole week." There was controversy at the start of the fourth game. With the match on serve, Sabalenka was hit with a hindrance call from the umpire for grunting, triggering a long video review and boos. A clearly irritated Sabalenka lost the point but recovered her poise and a break of serve early in the second set to surge home.

Bahrain Golf Championship bursts into action

Spain’s Del Rey, Germany’s Schott hold early lead after Round 1

Spain’s Alejandro Del Rey and Germany’s Freddy Schott made a spectacular start to the BAPCO Energies Bahrain Golf Championship yesterday, sharing the lead after the opening round with identical scores of 65, seven under par.

The tournament, held under the patronage of His Majesty King Hamad bin Isa Al Khalifa, has attracted 138 players from 28 countries and forms part of the DP World Tour, with a total prize fund of \$2.75 million. The championship continues today with the second round, with the final two rounds scheduled for Saturday and Sunday.

Del Rey, 27, has yet to miss a cut in the 2026 DP World Tour and carried his strong early-season form into Bahrain. He carded seven birdies, including three consecutive birdies to open his round, marking his lowest score of the season.

“The course felt softer than last year and the conditions were favourable early on,” Del Rey said. “I wanted to start aggressively and build momentum, and overall I hit the ball very well. I really enjoy this first swing here in the desert. The course suits me and I feel comfortable

playing here in January.”

Schott, 24, joined Del Rey at the top after an eventful round. Starting on the back nine, he surged with six birdies in his opening seven holes, but also dropped two shots. He finished strongly with a birdie-eagle on the 18th hole, cementing a share of the lead.

“It was a good round overall

— a strong start and a strong finish,” said Schott. “I just tried to stay focused and hit my comfortable shots, and it worked out in the end.”

One shot behind at six under par is a pack of four players, including defending champion Laurie Canter of England, Australia’s Daniel Hillier, Sweden’s Niklas Lemke, and Germany’s

Nicolai von Dellingshausen. Canter praised the course’s challenge, noting the importance of adapting to the wind while taking advantage of early scoring opportunities.

Veteran Irish golfer Pádraig Harrington praised Bahrain’s ongoing efforts to develop golf, highlighting improvements to the course and growing local

participation, while expressing satisfaction with his own form heading into a long season.

Among players with local connections, Tom Sloman, winner of the King Hamad Cup, posted 74 (+2), while Zubair Firdaus of Malaysia, champion of the Bahrain Open Amateur Championship, carded 75 (+3). Bahraini golfers Ali Al Kowari and Khalifa

Al Maraisi finished on 79 (+7) and 88 (+16) respectively.

Ten players will return this morning at 07:15 to complete their first round, which was suspended at 17:25 due to darkness. The second round takes place today, determining the cut as half the field will advance to the final two rounds on Saturday and Sunday.
